### **ORDER**

WHEREAS, Regional College of Physical Education, Panisagar North Tripura, Tripura-799260 (Code No. TR-SO/N-1/2000) was granted recognition for conducting B.P.Ed. course of one year duration with an intake of 60 from the academic session 2001-2002 vide ERC's order No. 1525 dated 28.05.2001.

- 2. AND WHEREAS, Revised Recognition Order (RRO) was issued for conducting B.Ed. course of two years duration with an intake of 100 from the academic session 2015-2016 vide ERC's No. F. ERC/NCTE/(TR-SO/N-1/2000)/B.P.Ed.(Revised Order)/2015/32650 dated 31.05.2015 as per NCTE Regulation, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.
- 3. AND WHEREAS, a Public Notice was uploaded on ERC's website on 30.01.2018, wherein 138 TEIs have not furnished their compliance reports in respect of conditions mentioned in the Revised Recognition Orders issued on or before 31st May, 2015 on the basis of implementation of NCTE Regulations, 2014. The ERC in its 254th meeting held on 16th 17th April, 2018 considered the matter and decided, 1st Show Cause Notice was issued on 20.04.2018 to the institution on the following grounds:
  - a. Approved faculty list (current) by the concerned affiliating body along with requisite documents.
  - b. Approved building plan by the concerned competent Govt. Engineer/Authority.
  - c. Approved building completion certificate by the concerned competent Govt. Engineer/Authority.
  - d. FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.
  - e. Confirmation on website updates of the institutions with all details along with affidavit.
- 4. **AND WHEREAS,** the institution submitted reply vide letter dated 08.05.2018, received in ERC, NCTE on 07.06.2018. The ERC in its 278<sup>th</sup> meeting held on 16<sup>th</sup> 18<sup>th</sup> January, 2020 considered the matter and decided, Final Show Cause Notice was issued on 27.01.2020 to the institution on the following grounds:-
  - (i) Original list of teaching faculty duly approved by the affiliating body to be submitted.
  - (ii) Building Plan (BP) is not legible. However, original copy of the Building Plan (BP) to be submitted.
  - (iii) Building Completion Certificate (BCC) duly signed by the competent authority to be submitted.

- (v) Requisite information of the institutional website has not updated as per clause 7(14)(i) of the NCTE Regulation, 2014.
- 5. **AND WHEREAS,** the institution submitted reply vide letter dated 11.02.2020, 29.02.2020 & 19.03.2020, received in ERC, NCTE on 24.02.2020, 06.03.2020 & 28.05.2020 respectively. The ERC in its 282<sup>nd</sup> meeting held on 08<sup>th</sup> 09<sup>th</sup> July, 2020 considered the original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and observed as under:-
  - (i) List of teaching faculty list is not in the NCTE prescribed proforma and also faculty is not appointed as per NCTE Regulation, 2014.

Hence, B.P.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2021-22.

- 6. NOW THEREFORE, recognition granted to the institution viz. Regional College of Physical Education, Panisagar North Tripura, Tripura- 799260 (Code No. TR-SO/N-1/2000) for B.P.Ed. Course is hereby withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2021-2022.
- 7. **FURTHER,** if the institution is not satisfied by the order, they can prefer an appeal Under Section 18 of the NCTE Act in the "Online mode" available on NCTE's website <a href="www.ncte.gov.in">www.ncte.gov.in</a> within 60 days from the date of the issue of the order.
