ORDER

WHEREAS, Uttar Banga B.P.Ed. College, Vill-Moregram, Via-Mangal Bari, PO-Madhaipur, Dist-Malda, West Bengal – 732142 (Code No.APE00866) was granted recognition for B.P.Ed. Course of one year duration with an annual intake of 50 (fifty)vide ERC order No.ERC/7-88.5.13/2008/12804 Dt.30-Aug-2008 from the Session 2008-2009 Under Clause 7(11) of NCTE (Recognition Norms & Procedure) Regulations, 2007.

- 2. AND WHEREAS the Eastern Regional Committee in its 144th ERC meeting considered the original files Code No.APE00866 & APE001045 along with other relevant documents submitted by the institution and decided to issue clarification on the following grounds:
 - 1). The same society applied for B.Ed programme for new recognition in different name i.e. Sidra B.Ed college on the same land.
 - 2). One institution of the same society i.e. Uttarbanga B.P.Ed. college is already recognized for B.P.Ed. course from 30.08.2008 on the same land.
 - 3). The society also requested vide letter No.08/NSDWM/SECY/KP-MAL/2012 dated 28.09.2012 that they are willing to surrender the B.P.Ed. course and want to start B.Ed. course in the name of Sidra B.Ed. College.
 - 4). Request of the institution (Trust) is accepted and institution be asked to submit an affidavit to the effect that they are willing to surrender the B.P.Ed. programme and start B.Ed. programme in the name of Sidra B.Ed. College.
 - 5). The land should be registered in the name of Sidra B.Ed. College or applicant society/trust.

Accordingly, a clarification letter No.14782 was issued on issued dt.20-Nov-2012.

3. AND WHEREAS the Secretary of the society viz. Nightingale Socio Development & Welfare Media, Vill-Kamalpur-Babla, PO-Meherapur, P.S, Kaliachak, Dist-Malda, West Bengal 732207 had submitted its representation dt.4-Dec-2012 in response to ERC clarification letter dt.20-Nov-2012 along with an affidavit for surrending the recognized B.P.Ed. Programme in the name of Uttar Banga B.P.Ed. College (Code No.APE00866) and starting B.Ed. Programme in the name of Sidra College (Code No.APE01045) in the same building and land. The said representation along with other documents and materials submitted by the institution were duly considered by the Eastern Regional Committee in its 147th meeting held on 17th – 18th December 2012, which decided as under:

"After considering the records available in the file, and relevant provisions of the NCTE Act 1993, Rules, Regulations and guidelines issued by NCTE Hqrs. and reply dated 04.12.2012 in response to clarification, the Committee discussed the matter in detail and observed as under:

The committee accepted the request of the institution and the recognition of Uttarbanga B.P.Ed. College for B.P.Ed. course is withdrawn from the session 2013-2014 and process the application of Sidra B.Ed. College, APE01045 as per NCTE Norms 2009."
