### **ORDER**

WHEREAS, Teachers Training College B.Ed. Aalo, Plot No.- 05/09, Street No. Aalo, Vill.-Bogdo, PO.- Aalo, Tehsil/Taluka-Aalo, Dist-West-Siang, Arunachal Pradesh-791001 was granted recognition for B.Ed. Course with an intake of 100 vide ERC Order No. ERC/7.138.6.32/NCTE/B.Ed./2012/13371 dated 18.08.2012 from the academic session 2012-2013, followed by revised recognition order No. F.ERC/NCTE/ERCAPP876/B.Ed. (Revised Order)/2015/31607 dt. 09.05.2015 with an intake of 100 (two basic units) from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

- 2. **AND WHEREAS**, the ERC in its  $279^{th}$  meeting held on  $14^{th}-16^{th}$  February, 2020 considered the matter and as decided, recognition granted to B.Ed. course was withdrawn u/s 17(1) of NCTE Act, 1993 vide order No.ER-279.4/(ERCAPP876)/B.Ed./2020/62401 dated 26.02.2020 from the academic session 2020-2021 to the institution.
- 3. **AND WHEREAS**, the institution preferred an appeal to the NCTE Hqrs. against the ERC's order dated 26.02.2020. The Appellate Authority vide its Order No. 89-116/E-158887/2020 Appeal/24<sup>th</sup> Mtg.-2020/23<sup>rd</sup> October, 2020/94950 dated 19.11.2020 decided that appellant institution is required to submit original B.C.C. and printout of website pages to ERC within 15 days of the issue of Appeal order. Appeal Committee further decided to remand back the case to ERC for revisiting the matter after the appellant submits the required documents.
- 4. **AND WHEREAS**, the institution has submitted the documents in response to NCTE Hqrs. Appellate Authority order dt. 19.11.2020.
- 5. **AND WHEREAS**, the ERC in its 288<sup>th</sup> meeting held on 29<sup>th</sup> January, 2021 considered the original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and appeal order dated 19.11.2020 and the committee decided as under:-

Restoration of recognition order of B.Ed. course with an annual intake of 100 (two units) be issued.

Aalo, Plot No.- 05/09, Street No. Aalo, Vill.-Bogdo, PO.-Aalo, Tehsil/Taluka-Aalo, Dist-West-Siang, Arunachal Pradesh-791001 for B.Ed. course is hereby restored recognition with an annual intake of 100 students (two units).
