ORDER

WHEREAS, Sipajhar B.Ed. College, P.O.-Sipajhar, Dist. - Darrang, Assam—784145 was granted recognition for B.Ed. Course with an intake of 100 vide ERC Order No. ERC/7-54/(ER-54.6(a).1)/2005/884 dated 18.03.2005 from the academic session 2005-2006, followed by revised recognition order No. F.ERC/NCTE/APE00314/B.Ed. (Revised Order)/2015/31773 dt. 20.05.2015 with an intake of 100 (two basic units) from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

- 2. **AND WHEREAS**, the ERC in its 283rd meeting held on 24th 25th August, 2020 considered the matter and as decided, recognition granted to B.Ed. course was withdrawn u/s 17(1) of NCTE Act, 1993 vide order No.ER-283.18/(APE00314)/B.Ed./2020/53003 dated 09.09.2020 from the academic session 2020-2021 to the institution.
- 3. **AND WHEREAS**, the institution preferred an appeal to the NCTE Hqrs. against the ERC's order dated 09.09.2020. The Appellate Authority vide its Order No. 89-234/E-168067/2020 Appeal/30th Mtg.-2020/3rd December, 2020/95778 dated 21.12.2020 decided that appellant institution is directed to forward to the ERC all the documents relating to the appointment of new Principal within 15 days of issue of orders on the appeal.
- 4. **AND WHEREAS,** the institution has submitted the documents in response to NCTE Hqrs. Appellate Authority order dt. 21.12.2020.
- 5. **AND WHEREAS**, the ERC in its 288th meeting held on 29th January, 2021 considered the original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and appeal order dated 21.12.2020 and the committee decided as under:-

Restoration of recognition order of B.Ed. course with an annual intake of 100 (two units) to be issued.

- 6. NOW THEREFORE, recognition withdrawn vide order dated 09.09.2020 to the institution viz. Sipajhar B.Ed. College, P.O.-Sipajhar, Dist.- Darrang, Assam- 784145 for B.Ed. course is hereby restored recognition with an annual intake of 100 students (two units).
- 7. The terms and conditions of the order F. F.ERC/NCTE/APE00314/B.Ed. (Revised Order)/2015/31773 dt. 20.05.2015 issued to the institution shall remain same.
