#### **ORDER**

WHEREAS, Dakshin Guwahati B.Ed. College, Fatasil Ambari, Guwahati, Assam was granted recognition for B.Ed. Course with an intake of 100 vide ERC Order No. ERC/7-57.4.1/2005/2121 dated 30.06.2005 from the academic session 2005-2006, followed by revised recognition order No. F.ERC/NCTE/APE00214/B.Ed. (Revised Order)/2015/31839 dt. 22.05.2015 with an intake of 100 (two basic units) from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

- 2. **AND WHEREAS**, the ERC in its 278<sup>th</sup> meeting held on 16<sup>th</sup> 18<sup>th</sup> July, 2019 considered the matter and as decided, recognition granted to B.Ed. course was withdrawn u/s 17(1) of NCTE Act, 1993 vide order No. 62253 dt.05.02.2020 from the academic session 2020-2021 to the institution.
- 3. **AND WHEREAS**, the institution preferred an appeal to the NCTE Hqrs. against the ERC's order dated 05.02.2020. The Appellate Authority vide its Order No. 89-247/E-169759/2020 Appeal/ 31<sup>st</sup> Mtg.-2020/4<sup>th</sup> December, 2020/95907 dated 24.12.2020 rejected the appeal and confirmed the order of ERC.
- 4. **AND WHEREAS**, the petitioner institution filed W.P.(C) No.755/2021 & CM APPL.1904/2021 dt. 18.01.2021 in the Hon'ble High Court Delhi. The Hon'ble Court disposed of the matter on 18.01.2021. The ERC in its 288<sup>th</sup> meeting held on 29<sup>th</sup> January, 2021considered the order passed by the Hon'ble High Court of Patna and decided as under:-

Restoration of recognition order of B.Ed. course with an annual intake of 100 (two units) be issued.

5. NOW THEREFORE, recognition withdrawn vide order dated 05.02.2020 to the institution viz. Dakshin Guwahati B.Ed. College, Fatasil Ambari, Guwahati, Assam for B.Ed. course is hereby restored recognition with an annual intake of 100 students (two units).
