ORDER

WHEREAS, S.K. Roy Memorial Institute of Education, Po – katlicherra, Lala, Dist – Hailakandi, Assam – 788161 was granted recognition for B.Ed. Course with an intake of 100 vide ERC Order No. ERC/7-103.4(I).14/2009/2884 dated 08.01.2010 from the academic session 2009-2010, followed by revised recognition order No. F.ERC/NCTE/ERCAPE00850/B.Ed. (Revised Order)/2015/31848 dt. 22.05.2015 with an intake of 100 (two basic units) from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

- 2. **AND WHEREAS**, the ERC in its 282nd meeting held on 8th 9th July, 2020 considered the matter and as decided, recognition granted to B.Ed. course was withdrawn u/s 17(1) of NCTE Act, 1993 vide order No.ER-282.24/(APE00850)/B.Ed./2020/62923 dated 14.08.2020 from the academic session 2021-2022 to the institution.
- 3. **AND WHEREAS**, the institution preferred an appeal to the NCTE Hqrs. against the ERC's order dated 14.08.2020. The Appellate Authority vide its Order No. 89-215/E-166666/2020 Appeal/29th Mtg.-2020/2nd December, 2020/95561 dated 16.12.2020 decided that appellant institution is required to submit with its appeal memoranda originals / copies of (i) Blue Print of approved Building Plan, (ii) Renewed FDRs, (iii) Printout of Website, (iv) Building Completion certificate and (v) List of faculty approved by Assam University. Appellant institution is required to resubmit originals / Xerox copies of all these documents to ERC within 15 days of the issued of appeal order. Appeal Committee further decided to remand back the case to ERC for revisiting the matter.
- 4. **AND WHEREAS,** the institution has submitted the documents in response to NCTE Hqrs. Appellate Authority order dt. 16.12.2020.
- 5. **AND WHEREAS**, the ERC in its 288th meeting held on 29th January, 2021 considered the original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and appeal order dated 16.12.2020 and the committee decided as under:

Restoration of recognition order of B.Ed. course with an annual intake of 100 (two units) be issued.

- 7. The terms and conditions of the order F.ERC/NCTE/ERCAPE00850/B.Ed. (Revised Order)/2015/31848 dt. 22.05.2015 issued to the institution shall remain same.
