ORDER

WHEREAS, Govt. Teacher's Training College, Turki, Muzaffarpur, Bihar-844127 was granted recognition for B.Ed. Course with an annual intake of 100 vide Order No.2236-2242 dated 05.01.2006 from the academic session 2006-2007, followed by revised recognition vide order No.32386 dated 29.05.2015 with an annual intake of 100 (Two Basic Units) from the academic session 2015-2016 as per NCTE Regulations, 2014.

- 2. **AND WHEREAS**, as per decision of the ERC taken in its 275th meeting held on 27th July, 2019, recognition to B.Ed. course was withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021. Accordingly, withdrawal order videNo.61426 dated 28.08.2019 was issued to the institution.
- 3. **AND WHEREAS**, the institution preferred an appeal to the NCTE Hqrs. against the withdrawal order dated 28.08.2019 of ERC. The Appellate Authority vide order No.89-50/E-154661/2020 Appeal/21st Mtg.-2020/7th September, 2020/94792 dated 04.11.2020 remanded back to the ERC with a direction to consider the approved faculty list, to be submitted to them by the appellant, and take necessary action as per the NCTE Regulation, 2014. The appellant is directed to forward to the ERC the approved faculty list along with copies of their letters dt.07.09.2020 and 21.08.2020 within 15 days of receipt of orders on the appeal.
- 4. **AND WHEREAS**, as per order of the Appellate Authority, the institution submitted representations dated 11.11.2020, 02.12.2020 & 08.12.2020 received on 17.11.2020, 09.12.2020 & 11.12.2020 respectively to the ERC. The ERC in its 288th meeting held on 29th January, 2021 considered the original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, appeal order dated 04.11.2020 and Committee decided as under:-

Restoration of recognition order of B.Ed. course with an annual intake of 100 students (two units) be issued.

5. **NOW THEREFORE**, recognition withdrawn vide order dated 28.08.2019 to the institution viz. Govt. Teacher's Training College, Turki, Muzaffarpur, Bihar-844127for B.Ed. course is hereby restored with annual intake of 100 (Two units).
