ORDER

WHEREAS, Bihar College of Education, Plot No.2110, 2112, 2113, 2116, 2126, Vill - Jadhua Baraitola, Po/Town/City-Hajipur, Tehsil/Taluka-Hajipur, Dist-Vaishali, Bihar-844101 was granted recognition for B.Ed. Course with an annual intake of 100 vide Order No.24429 dated 03.03.2014 from the academic session 2014-2015, followed by revised recognition vide order No.32648 dated 31.05.2015 with an annual intake of 100 (Two Basic Units) from the academic session 2015-2016 as per NCTE Regulations, 2014.

2. AND WHEREAS, as per decision of the ERC taken in its 283rd meeting held on 24th – 25th August, 2020, recognition to B.Ed. course was withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2021-2022. Accordingly, withdrawal order vide No.63033 dated 15.09.2020 was issued to the institution.

3. AND WHEREAS, the institution preferred an appeal to the NCTE Hqrs. against the withdrawal order dated 15.09.2020 of ERC. The Appellate Authority vide order No.89-228/E-167480/2020 Appeal/30th Mtg.-2020/3rd December, 2020/95754 dated 21.12.2020 remanded back the case to the ERC with a direction to consider the documents, to be submitted to the ERC office by the appellant, and take further necessary action as per NCTE Regulation, 2014. The appellant is directed to forward to the ERC, all the documents submitted in appeal, with originals thereof, wherever necessary within 15 days of the issue of orders on the appeal.

4. AND WHEREAS, as per order of the Appellate Authority, the institution submitted representations dated 24.12.2020 received on 29.12.2020. The ERC in its 288th meeting held on 29th January, 2021 considered the original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, appeal order dated 21.12.2020 and Committee decided as under:-

Restoration of recognition order of B.Ed. course with an annual intake of 100 students (two units) be issued.

5. NOW THEREFORE, recognition withdrawn vide order dated 15.09.2020 of the institution viz. Bihar College of Education, Plot No.2110, 2112, 2113, 2116, 2126, Vill Jadhua Baraitola, Po/Town/City-Hajipur, Tehsil/Taluka-Hajipur, Dist-Vaishali, Bihar-844101 for B.Ed. course is hereby restored with annual intake of 100 (Two units).
