### **ORDER**

WHEREAS, Magadh Teacher's Training College, West Church Road, Near D.M. Residence, Dist – Gaya, Bihar – 823001 was granted recognition for B.Ed. Course with an annual intake of 100 vide Order No.10971 (32) dated 30.04.2008, followed by revised recognition vide order No.32584 dt.31.05.2015 with an annual intake of 100 (Two Basic Units) from the academic session 2015-2016 as per NCTE Regulations, 2014.

- 2. **AND WHEREAS**, as per decision of the ERC taken in its 279<sup>th</sup> meeting held on 14<sup>th</sup> 16<sup>th</sup> February, 2020, the recognition to B.Ed. course was withdrawn from the academic session 2020-2021. Accordingly, orderwithdrawing recognition videNo.62453 dt.28.02.2020 was issued to the institution.
- 3. **AND WHEREAS**, the institution preferred an appeal to the NCTE Hqrs. against the withdrawal order dt.28.02.2020 of ERC. The Appellate Authority vide order No.89-218/E-166972/2020 Appeal/29<sup>th</sup> Mtg. 2020/2<sup>nd</sup> December, 2020/95573 dt.16.12.2020decided that the appellant is required to submit to ERC within 15 days of the issue of Appeal order original Building Completion Certificate and FDRs with Form 'A'. Appeal Committee further decided to remand back the case to ERC for revisiting the matter.
- 4. **AND WHEREAS**, the institution filed a petition W.P.(C) 10710/2020 & CM APPL. No.33611/2020 in the Hon'ble High Court of Delhi and theHon'bleCourt disposed of the matter on 18.12.2020 with direction that the respondents will take all consequential steps forthwith for permitting the petitioner to participate in the counselling for the current academic session. Appropriate intimation will be sent to the concerned authority/ affiliating university, to the Department of Higher Education of the concerned State and appropriate changes may be carried out forthwith on the website.
- 5. **AND WHEREAS**, the ERC in its 288<sup>th</sup> meeting held on 29<sup>th</sup> January, 2021 considered the original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, Order dated 18.12.2020 passed by Hon'ble High Court of Delhi, appeal order dated 16.12.2020 and Committee decided as under:-

Restoration of recognition order of B.Ed. course with an annual intake of 100 students (Two Units) be issued.

6. **NOW THEREFORE**, recognition withdrawn vide order dated 05.08.2019 to the institution viz. Magadh Teacher's Training College, West Church Road, Near D.M. Residence, Dist-Gaya, Bihar-823001 for B.Ed. course is hereby restored with total annual intake of 100 (Two units).
