**ORDER**

WHEREAS, Ram krishna College, Plot No.1538, 1539, 1540, 1541, 1542, 1543, Vill-College Road, Po. Madhubani, Tehsil/Taluka-Rahika, Town/City-Madhubani, Dist-Madhubani, Bihar-847211 was granted recognition for B.Ed. Course with an annual intake of 100 vide ERC Order No.20579 dated 31.08.2013 from the academic session 2014-2015, followed by revised recognition vide order No.31963 dated 23.05.2015 with an annual intake of 100 (Two Basic Units) from the academic session 2015-2016 as per NCTE Regulations, 2014.

2. AND WHEREAS, as per decision of the ERC taken in its 274<sup>th</sup> meeting held on 15<sup>th</sup> – 16<sup>th</sup> July, 2019, recognition to B.Ed. course was withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021. Accordingly, withdrawal order vide No.61555 dated 11.09.2019 was issued to the institution.

3. AND WHEREAS, the institution preferred an appeal to the NCTE Hqrs. against the withdrawal order dated 11.09.2019 of ERC. The Appellate Authority vide Order No.89-505/E-148076/2019 Appeal/6<sup>th</sup> Mtg.-2020/24<sup>th</sup> February, 2020/90385 dated 19.03.2020 remanded back to the ERC with a direction to consider the documents given in appeal, to be submitted to them by the appellant, and take further action as per NCTE Regulation, 2014. The appellant is directed to forward to the ERC the documents submitted in appeal and copies of their website containing all the required information, within 15 days of receipt of orders on the appeal.

4. AND WHEREAS, as per order of the Appellate Authority, the institution submitted representation dated 20.03.2020 received on 08.05.2020. The ERC in its 284<sup>th</sup> meeting held on 17<sup>th</sup> – 18<sup>th</sup> September, 2020 considered the matter and accordingly, Show Cause Notice was issued to the institution dated 07.10.2020.

5. AND WHEREAS, reply dated 01.10.2020 in response to the Show Cause Notice submitted by the institution received on 08.10.2020. The ERC in its 288<sup>th</sup> meeting held on 29<sup>th</sup> January, 2021 considered the original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time were carefully considered by ERC and the Committee decided as under:-

**Restoration of recognition order of B.Ed. course with an annual intake of 100 students (two units) be issued.**

5. **NOW THEREFORE**, recognition withdrawn vide order dated 11.09.2019 to the institution viz. Ram krishna College, Plot No.1538, 1539, 1540, 1541, 1542, 1543, Vill-College Road, Po. Madhubani, Tehsil/Taluka-Rahika, Town/City-Madhubani, Dist- Madhubani, Bihar-847211 for **B.Ed. course** is hereby **restored with annual intake of 100 (Two units)**.

6. The terms and conditions of the order No.31963 dated 23.05.2015 issued to the institution shall remain unchanged.
