ORDER

Whereas, the institution Sahadev Chandravansi B.Ed. College, Vill.- Nawadih Kala, P.O.- Bishrampur, Dist.- Palamu, Jharkhand- 822124 (Code No. APE00910) was granted recognition for conducting B.Ed. course of one year duration with an annual intake of 100 students from the academic session 2009-2010 vide ERC's order no. ERC/7-90.6(1).13/2008/13704 dt. 06.11.2008.

- 2. And whereas, a Revised Recognition Order (RRO) was issued to the institution vide ERC's order no. ERC/NCTE/APE00910/B.Ed.(Revised Order)/2015/32684 dt. 31.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.
- 3. And whereas, the ERC in its 279^{th} meeting held $14^{th} 16^{th}$ July, 2020 considered the matter and decided as follows:-
 - (i) Building Completion Certificate (BCC) is not duly signed by the competent authority.
 - (ii) Building Plan (BP) IS not duly approved by the competent authority.
 - (iii) Website of the institution IS not functional as per clause 7(14)(i) of the NCTE Regulation, 2014.

Hence, B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2020-21.

Accordingly, recognition was withdrawn, u/s 17(1) of the NCTE Act, 1993, vide order no. F.No. ER-279.17/ APE00910/B.Ed./2020/62422 dt. 26.02.2020 from the academic session 2020-2021.

- 4. And whereas, the institution preferred an appeal to the NCTE Hqrs. against the withdrawal order dated 26.02.2020 and the Appellate Authority vide order no.89-160/E-162498/2020 Appeal/25th Mtg.-2020/26th October, 2020/95156 dt. 27.11.2020 remanded back the case to the ERC for revisiting the matter as per directions of the appellate authority.
- 5. And whereas, the institution has submitted a reply dt. 08.12.2020 and the ERC in its 288th meeting held on 29th January, 2021 considered the reply submitted by the institution alongwith original regulatory file & other related documents, NCTE Act, 1993, Regulations & Guidelines issued by NCTE from time to time and decided as under:-

Restoration of recognition order of B.Ed. course with an annual intake of 100 (two units) be issued.

- 6. Now therefore, recognition withdrawn vide order dt. 26.02.2020 of Sahadev Chandravansi B.Ed. College, Vill.- Nawadih Kala, P.O.- Bishrampur, Dist.- Palamu, Jharkhand- 822124 (Code No. APE00910) for conducting B.Ed. course of two years duration with an annual intake of 100 students (two units) is hereby restored from session 2021-2022.
- 7. The terms and conditions of the order No. F. ERC/NCTE/APE00910/B.Ed.(Revised Order)/2015/32684 dt. 31.05.2015 issued to the institution shall remain same.
