#### **ORDER**

Whereas, the institution Radha Govind Teacher's Training (M.Ed.) College, Behind Ramgarh College, Ramgarh Cantt., Dist.- Hazaribagh, Jharkhand- 829122 (Code No. APE00794) was granted recognition for M.Ed. course of one year duration with an annual intake of 25 students from the academic session 2009-2010 vide ERC's order no. ERC/7-95.6(1).12/2009/16542 dt. 15.05.2009.

- 2. And whereas, a Revised Recognition Order (RRO) was issued to the institution vide ERC's order no. ERC/NCTE/APE00794/M.Ed.(Revised Order)/2015/32681 dt. 31.05.2015 for conducting M.Ed. course of two years duration with an annual intake of 50 (one unit) students from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.
- 3. And whereas, the ERC in its 280<sup>th</sup> meeting held 29<sup>th</sup> February & 1<sup>st</sup> March, 2020 considered the matter and decided as follows:-
  - (i) There is a mismatch of built up area m both Building Plan (BP) & Building Completion Certificate (BCC).
  - (ii) Photocopy of Building Plan (BP) is in piecemeal and not approved by competent authority.

Hence, M.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2020-21

Accordingly, recognition was withdrawn, u/s 17(1) of the NCTE Act, 1993, vide order no. F.No.ER-280.65/APE00794/M.Ed./2020/62555 dt. 03.03.2020 from the academic session 2020-2021.

- 4. And whereas, the institution preferred an appeal to the NCTE Hqrs. against the ERC's order dated 03.03.2020. The Appellate Authority vide its order no.89-83/E-156786/2020 Appeal/13<sup>th</sup> Mtg.-2020/27<sup>th</sup> July, 2020/93128 dt. 15.09.2020 remanded back the case to ERC for revisiting as per directions of the appellate authority.
- 5. And whereas, the institution submitted reply dt. 23.09.2020 & 28.10.2020. The ERC in its 286<sup>th</sup> meeting held on 25<sup>th</sup> & 26<sup>th</sup> November, 2020 considered the reply of the institution and decided to issue show cause notice and the same was issued on 04.12.2020 to the institution on the following grounds:-
  - (i) Latest Building Completion Certificate (BCC), in the NCTE prescribed profomma, clearly mentioning the built-up area dedicated to existing and proposed teacher training institution duly signed by the concerned Govt. Authority to be submitted.
  - (ii) Blueprint of Building Plan (BP) mentioning the details of Plot No./khasra No., total land area, total built up area etc. duly approved by the concerned Govt. Civil Engineer to be submitted.

Hence, show cause notice under section 17 of the NCTE Act, 1993 be issued to the institution to submit reply within 30 days from the date of issue of show cause notice.

And whereas, the institution submitted reply dt. 14.12.2020 and the ERC in its 288<sup>th</sup> meeting held on 29<sup>th</sup> January, 2021 considered the reply submitted by the institution alongwith original regulatory file & other related documents, NCTE Act, 1993, Regulations & Guidelines issued by NCTE from time to time and decided as under:-

### Restoration of recognition order of M.Ed. course with an annual intake of 50 (one unit) be issued.

- 7. Now therefore, recognition withdrawn vide order dt. 03.03.2020 of Radha Govind Teacher's Training (M.Ed.) College, Behind Ramgarh College, Ramgarh Cantt., Dist.- Hazaribagh, Jharkhand- 829122 (Code No. APE00794) for conducting M.Ed. course of two years duration with an annual intake of 50 students (one unit) is hereby restored from session 2021-2022.
- 8. The terms and conditions of the order No. F. ERC/NCTE/APE00794/M.Ed.(Revised Order)/2015/32681 dt. 31.05.2015 issued to the institution shall remain same.
