ORDER

Whereas, the institution Sri Ramakrishna Sarada Ashrama Teacher's Training College, Plot No.- 1666, 1671, 1670, 1672, 1698, 1700, At/P.O.- Hazaribagh, Dist.- Hazaribagh, Jharkhand- 825301 (Code No. ERCAPP48) was granted recognition for conducting B.Ed. course of one year duration with an annual intake of 100 students from the academic session 2012-2013 vide ERC's order no. ERC/7-136.6.36/NCTE/B.Ed./2012/12820 dt. 22.07.2012.

- 2. And whereas, a Revised Recognition Order (RRO) was issued to the institution vide ERC's order no. ERC/NCTE/ERCAPP48/B.Ed.(Revised Order)/2015/32707 dt. 31.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.
- 3. And whereas, the ERC in its 284^{th} meeting held $17^{th} 18^{th}$ September, 2020 considered the matter and decided as follows:-
 - (i) Sampati Paul possesses 52% marks in Master Degree, which is not permissible as per Regulation, 2014.
 - (ii) Soma Sarkar possesses 50% marks in Master Degree, which is not permissible as per Regulation, 2014.
 - (iii) There is mismatch between Building Plan (BP) and Building Completion Certificate (BCC). However, latest Building Plan (BP) is not submitted.
 - (iv) Original FDRs Rs. 5 lakh and Rs. 7 lakh is not submitted.
 - (v) Certified copy of registered land document is not submitted.
 - (vi) Validity of Fire Safety Certificate has been expired on 18.11.2019.

Hence, B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2021-22.

Accordingly, recognition was withdrawn, u/s 17(1) of the NCTE Act, 1993, vide order no. F.No.ER-284.14/ERCAPP48/B.Ed./2020/63082 dt. 29.09.2020 from the academic session 2021-2022.

- 4. And whereas, the institution preferred an appeal to the NCTE Hqrs. Against the withdrawal order dated 29.09.2020 and the Appellate Authority vide order no.89-259/E-170399/2020 Appeal/31st Mtg.-2020/4th December, 2020/95939 dt. 24.12.2020 remanded back the case to the ERC for revisiting the matter as per directions of the appellate authority.
- 5. And whereas, the institution has submitted a reply dt. 26.12.2020 and the ERC in its 288th meeting held on 29th January, 2021 considered the reply submitted by the institution alongwith original regulatory file & other related documents, NCTE Act, 1993, Regulations & Guidelines issued by NCTE from time to time and decided as under:-

Restoration of recognition order of B.Ed. course with an annual intake of 100 (two units) be issued.

Now therefore, recognition withdrawn vide order dt. 29.09.2020 of Sri Ramakrishna Sarada Ashrama Teacher's Training College, Plot No.- 1666, 1671, 1670, 1672, 1698, 1700, At/P.O.- Hazaribagh, Dist.- Hazaribagh, Jharkhand- 825301 (Code No. ERCAPP48) for conducting B.Ed. course of two years duration with an annual intake of 100 students (two units) is hereby restored from session 2021-2022.
- 7. The terms and conditions of the order No. F. ERC/NCTE/ERCAPP48/B.Ed.(Revised Order)/2015/32707 dt. 31.05.2015 issued to the institution shall remain same.
