ORDER

WHEREAS, Bosco College of Teacher Education, Dimapur, Nagaland-797112 was granted recognition for B.Ed. Course with an intake of 100 vide ERC Order No. ERC/7-31(ER-31.10.6)/2003/243 dated 28.01.2003 from the academic session 2003-2004, followed by revised recognition order No. F.ERC/NCTE/(NA-S/N-1/2000)/APE00168/B.Ed. (Revised Order)/2015/31888 dt. 23.05.2015 with an intake of 100 (two basic units) from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

- AND WHEREAS, as per decision of the ERC taken in its 274th meeting held on 15th 16th July, 2019, order vide No.61355 dt.22.08.2019 issued to the institution reducing the intake from 100 to 50 from the academic session 2020-2021.
- AND WHEREAS, the institution preferred an appeal to the NCTE Hqrs. against the ERC's order dated 22.08.2019. The Appellate Authority vide its Order No. 89-185/E-164789/2020 Appeal/ 26th Mtg.-2020/27th October, 2020/95212 dated 27.11.2020, Appeal Committee concluded to remand back the case to the ERC with a direction to consider the faculty list sent to them by the appellant and take necessary action on the request of the appellant, to restore the intake in B.Ed. course to 100.
- AND WHEREAS, the institution has submitted the documents in response to NCTE Hqrs. 4. Appellate Authority order dt. 27.11.2020.
- AND WHEREAS, the ERC in its 288th meeting held on 29th January, 2021 considered the original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and appeal order dated 27.11.2020 and the committee decided as under :-

Restoration of recognition order for B.Ed. course for another one unit (50 intake) to be issued. Hence, the total two units (100 intake) is permitted.

NOW THEREFORE, order dated 22.08.2019 reducing the intake from 100 to 50 issued to the institution viz. Bosco College of Teacher Education, Dimapur, Nagaland-797112 for B.Ed. course is hereby restored permitting another, intake of 50 (One Unit) making the total annual intake of 100 (two basic units).
