#### **ORDER**

WHEREAS, Shyamangini Kundu College of Education, Plot No.-12265, 12266, Street No. -Kagram Sal, Vill-Salar, PO-Salar, Tehsil/Taluka-Salar, Town/City-Salar, Dist-Murshidabad, West Bengal-742401 (ERCAPP550) was granted recognition for B.Ed. course with an annual intake of 100 from the academic session 2012-2013 vide ERC order dated 31.08.2012, followed by revised recognition order issued on 25.05.2015 with an annual intake of 100 (two basic units) from the academic session 2015-2016 as per NCTE Regulation, 2014.

2. **AND WHEREAS,** the ERC in its  $278^{\text{th}}$  meeting held on  $16^{\text{th}} - 18^{\text{th}}$  January, 2020 considered the matter and decided to withdraw recognition to B.Ed. course u/s 17(1) of NCTE Act 1993 from the academic session 2020-2021. Accordingly, withdrawal order was issued vide F.No.ER-278.54/ERCAPP550/B.Ed./2020/62266 dated 05.02.2020 to the institution.

3. **AND WHEREAS,** the institution preferred an appeal to NCTE HQs. against the ERC's order dated 05.02.2020. The Appellate Authority vide order No.89-197/E-165468/2020 Appeal/26<sup>h</sup> Mtg.-2020/27<sup>th</sup> October, 2020/95236 dated 27.11.2020 decided to set aside the impugned order of withdrawal dated 05.02.2020. Appellant institution is however, required to submit to ERC renewed FDRs.

4. **AND WHEREAS,** the institution submitted reply vide letter dated 02.12.2020 received on 07.12.2020. The original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and appeal order dated 27.11.2020, were carefully considered by ERC in its 288<sup>th</sup> meeting held on 29<sup>th</sup> January, 2021 and the committee decided as under:-

"Restoration of recognition order of B.Ed. course with an annual intake of 100 (two units) be issued.

5. NOW, THEREFORE, recognition withdrawn vide order no. F.No.ER-278.54/ERCAPP550/B.Ed./2020/62266 dated 05.02.2020 to the institution viz. Shyamangini Kundu College of Education, Plot No.-12265, 12266, Street No. -Kagram Sal, Vill-Salar, PO-Salar, Tehsil/Taluka-Salar, Town/City-Salar, Dist-Murshidabad, West Bengal-742401 (Code No. ERCAPP550) for B.Ed. Course is hereby restored recognition with an annual intake of 100 (two units).
