**ORDER**

WHEREAS, Srijoni College of Education, Vill.-Dakshin Chandipur, P.o. - Kota, P.S. - Dubrajpur, Dist.-Birbhum, West Bengal-731124 (ERCAPP65/2012) was granted recognition for B.Ed. course with an annual intake of 100 from the academic session 2014-2015 vide ERC order dated 03.03.2014, followed by revised recognition order dated 30.05.2015 with an annual intake of 100 (two basic units) from the academic session 2015-2016 as per NCTE Regulation, 2014.

2. **AND WHEREAS**, the ERC in its 279<sup>th</sup> meeting held on 14<sup>th</sup> – 16<sup>th</sup> February, 2020 considered the matter and decided to withdraw recognition to B.Ed. course u/s 17(1) of NCTE Act 1993 from the academic session 2020-2021. Accordingly, withdrawal order was issued vide No. F.No.ER-279.63/ERCAPP65/2012/B.Ed./2020/62541 dated 03.03.2020 to the institution.

3. **AND WHEREAS**, the institution preferred an appeal to NCTE HQs. against the ERC's order dated 03.03.2020. The Appellate Authority vide order No.89-100/E-158022/2020 Appeal/15<sup>th</sup> Mtg.-2020/29<sup>th</sup> July, 2020/93184 dated 15.09.2020 decided that appellant institution is required to submit, within 15 days of the issue of appeal order, to ERC, (i) Renewed FDRs, (ii) Fire Safety Certificate, (iii) Printout of website. Appeal Committee, further decided to remand back the case to ERC for revisiting the matter.

4. **AND WHEREAS**, the institution has submitted representation vide letter dated 16.09.2020 received on 23.09.2020. The ERC in its 284<sup>th</sup> meeting held on 17<sup>th</sup> – 18<sup>th</sup> September, 2020 considered the matter and as decided, Show Cause Notice was issued on 05.10.2020 to the institution.

5. **AND WHEREAS**, the institution submitted reply vide letter dated 07.12.2020 received in this office on 15.12.2020. The original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by ERC in its 288<sup>th</sup> meeting held on 29<sup>th</sup> January, 2021 and the committee decided as under:-

“Restoration of recognition order of B.Ed. course with an annual intake of 100 (two units) be issued.

6. **NOW, THEREFORE**, recognition withdrawn vide order no. F.No.ER-279.63/ERCAPP65/2012/B.Ed./2020/62541 dated 03.03.2020 to the institution viz. Srijoni College of Education, Vill.-Dakshin Chandipur, Po- Kota, PS- Dubrajpur, Dist.-

**Birbhum, West Bengal-731124 (Code No. ERCAPP65/2012) for B.Ed. Course is hereby restored recognition with an annual intake of 100 (two units).**

7. The terms & conditions of the Order No. F.ERC/NCTE/ERCAPP65/2012/B.Ed.(Revised Order)/2015/32513 dated 30.05.2015 issued to the institution shall remain unchanged.
