ORDER

WHEREAS, Nikhil Banga Sikshan Mahavidyalaya, P.O. Bishnupur, Dist. Bankura, West Bengal-722122 (Code No.APE00336) was granted recognition for B.Ed. course with an intake of 100 vide ERC order dated 12.03.2007, followed by revised order vide No. 32250 dated 27.05.2015 with an annual intake of 50 (one basic unit of 50 students) from the academic session 2015-2016 as per NCTE Regulations, 2014.

- 2. **AND WHEREAS,** the ERC in its 278th meeting held on 16th 18th January 2020, considered the matter and as decided, recognition granted to B.Ed. course was withdrawn u/s 17(1) of NCTE Act 1993 from the academic session 2020-2021. Accordingly, withdrawal order was issued vide No. ER- 278.48/APE00336/B.Ed./2020/62262 dated 05.02.2020 to the institution.
- 3. **AND WHEREAS,** the institution preferred an appeal to NCTE HQs. against the ERC order dated 05.02.2020. The Appellate Authority vide order No.89-56/E-154886/2020 Appeal/11th Mtg.- 2020/23rd July, 2020/93040 dated 15.09.2020 remanded back the case to ERC for revisiting the matter considering the list of faculty submitted by appellant institution by its letter dated 27.08.2019.
- 4. **AND WHEREAS**, the institution submitted representations dated 24.01.2020 & 18.09.2020 received on 27.01.2020,13.02.2020 & 28.09.2020. The ERC in its 286th meeting held on 25th & 26th November, 2020 considered the matter and as decided, show cause notice u/s 17 of NCTE Act, 1993 was issued to the institution dated 09.12.2020 on the following ground:
 - ➤ The qualified teaching faculty for Music and Fine Arts have not been appointed as prescribed in Appendix-4 of NCTE Regulation, 2014.
- 5. **AND WHEREAS**, the institution submitted reply dated 30.12.2020 in response to show cause notice, received on 04.01.2021. The original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by ERC in its 288th meeting held on 29th January, 2021 and the Committee decided as under:
 - Restoration of recognition order of B.Ed. course with an annual intake of 50 (one unit) be issued.

- 6. NOW, THEREFORE, recognition withdrawn vide order No. ER- 278.48/APE00336/B.Ed./2020/62262 dtd. 05.02.2020 to the institution viz. Nikhil Banga Sikshan Mahavidyalaya, P.O. Bishnupur, Dist. Bankura, West Bengal-722122 (Code No. APE00336) for B.Ed. course is hereby restored recognition with an annual intake of 50 students (one unit).
- 7. The terms and conditions of the order No. F. ERC/NCTE/APE00336 /B.Ed. (Revised Order) /2015/32250 dated 27.05.2015 issued to the institution shall remain unchanged.
