2. **AND WHEREAS**, the ERC in its 274^h meeting held on $15^{th} - 16^{th}$ July, 2019 considered the matter and as decided, recognition granted to B.Ed. course was withdrawn u/s 17(1) of NCTE Act, 1993 from the academic session 2020-2021. Accordingly, withdrawal order was issued vide No. ER-274.14.25 /APE00787 /B.Ed. /2019/61300 dated 20.08.2019 to the institution.

3. **AND WHEREAS**, the institution preferred an appeal to NCTE HQs. against the ERC's order dated 20.08.2019. The Appellate Authority vide order No. 89-472/E-143562/2019 Appeal/3rd Mtg..-2020/31st January, 2020/89742, dated 02.03.2020 decided to set aside the impugned order of withdrawal dated 20.08.2019.

4. **AND WHEREAS**, the institution submitted representations dated 10.09.2020 & 12.09.2020 received on 14.09.2020 & 17.09.2020. The ERC in its 284^{th} meeting held on $17^{\text{th}} - 18^{\text{th}}$ September, 2020 considered the matter and as decided, show cause notice u/s 17 of the NCTE Act, 1993 issued to the institution dated 05.10.2020 on the following ground:

Original FDRs of Rs. 5 lakh and Rs. 7 lakh in a joint mode as per NCTE Regulation, 2014 to be submitted.

5. AND WHEREAS, the institution submitted reply dated 24.09.2020 & 02.11.2020 in response to show cause notice received on 29.09.2020 & 02.12.2020. The original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by ERC in its 288th meeting held on 29th January, 2021 and the Committee decided as under:

Restoration of recognition order of B.Ed. course with an annual intake of 100 (two units) be issued.
