ORDER

WHEREAS, Panskura Banamali College, PO – Panskura R.S., Dist – Purba Medinipur, West Bengal – 721152 (APE00695) was granted recognition for B.P.Ed. course with an annual intake of 50 from the academic session 2008-2009 vide ERC's order dated 05.08.2008. Revised recognition order issued on 28.05.2015 with an annual intake of 50 for one basic unit from the academic session 2015-2016 as per NCTE Regulation, 2014, followed by corrigendum issued vide no. 33971 dated 17.07.2015 with a basic unit of 100 (one hundred) students with two sections of 50 (fifty) each from the academic session 2015-2016.

- 2. **AND WHEREAS,** the ERC in its 278th meeting held on 16th 18th January, 2020 considered the matter and decided to withdraw recognition to B.P.Ed. course u/s 17(1) of NCTE Act 1993 from the academic session 2020-2021. Accordingly, withdrawal order was issued vide F.No.ERC-278.55/APE00695/B.P.Ed./2020/62268 dated 05.02.2020 to the institution.
- 3. **AND WHEREAS**, the institution preferred an appeal to NCTE HQs. against the ERC's order dated 05.02.2020. The Appellate Authority vide order No.89-67/E-155812/2020 Appeal/12th Mtg.-2020/24th July, 2020/93072 dated 15.09.2020 decided that appellant is required to once again forward to ERC within 15 days of the issue of Appeal order. The copies of Building Plan and Building Completion Certificate. Appeal Committee further concluded to remand back the case ERC for revisiting the matter.
- 4. **AND WHEREAS**, the institution has submitted representation vide letter dated 18.09.2020 received on 22.09.2020. The ERC in its 286^{th} meeting held on $25^{th} 26^{th}$ November, 2020 considered the matter and as decided, Show Cause Notice was issued on 09.12.2020 to the institution.
- 5. **AND WHEREAS**, the institution submitted reply vide letters dated 16.12.2020 & 21.12.2020 received on 21.12.2020 & 24.12.2020. The original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by ERC in its 288th meeting held on 29th January, 2021 and the committee decided as under:-

"Restoration of recognition order of B.P.Ed. course with an annual intake of 100 with two sections of 50 each be issued.

Panskura Banamali College, PO Panskura R.S., Dist Purba Medinipur, West Bengal 721152 (Code No. APE00695) for B.P.Ed. Course is hereby restored recognition with an annual intake of 100 with two sections of 50 each.
- 7. The terms & conditions of the Order No. F.ERC/NCTE/APE00695/B.P.Ed.(Revised Order)/2015/32320 dated 28.05.2015 issued to the institution shall remain unchanged.
