<u>ORDER</u>

WHEREAS, Burdwan University, Institute of Science Education (Presently, **Department of Education**), **Rajbati**, **Burdwan**, **West Bengal-713104** (WB-S/N-1/99) was granted recognition for B.Ed. course with an intake of 70 from the academic Session 2002-2003 vide ERC Order No. 2087 dated 17.07.2002, followed by revised order vide No.32435 dated 30/05/2015 an intake of 50 (one basic unit) from the academic Session 2015-2016 as per NCTE Regulations, 2014

2. **AND WHEREAS,** the ERC in its 272nd meeting held on 30th – 31st May & 1st June, 2019 considered the matter and as decided, recognition granted to B.Ed. Course u/s17(1) of NCTE, Act, 1993 from the academic session 2020-2021. Accordingly, Withdrawal Order vide No. ER. 272.14.157/WB-S/N-1/99)/ B.Ed./2019/60689 dated 14.06.2019 was issued to the institution.

3. **AND WHEREAS,** the institution preferred an appeal to NCTE, HQs. against the ERC's Order dated 14.06.2019. The Appellate Authority vide order No.F.No.89-321/E- 130187/2019 Appeal/9th Mtg.- 2020/28th February, 2020/91518, dated 15.07.2020 decided to remanded back the case to ERC for revisiting the matter after the appellate submits copies of the required documents.

4. **AND WHEREAS**, the institution submitted representation dated 07.08.2020 received on 18.08.2020. The ERC in its 283rd meeting held on 24th & 25th August 2020 considered the matter and as decided, show cause notice u/s 17 of the NCTE Act, 1993. Accordingly, show cause notice issued to the institution dated 07.09.2020 on the following ground:-

(i) No details mentioned in the Building Plan (BP) including the plot No./ khasra No., total land area and total built up area etc. duly approved by the competent authority to be submitted.

6. **AND WHEREAS**, the institution submitted two letters reply dated 14.09.2020 in response to show cause notice received on 21.09.2020 & 29.09.2020. The original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by ERC in its 288th meeting held on 29th January, 2021 and the Committee decided as under:

Restoration of recognition order of B.Ed. course with an annual intake of 50 (one unit) be issued.
