ORDER

WHEREAS, Loreto College, 7, Middleton Row, Calcutta, West Bengal-700071 (WB-S/E-1/99) was granted recognition for B.Ed. course with an annual intake of 60 vide ERC's order dated 23.11.1998. Revised recognition order issued on 31.05.2015 with an annual intake of 50 for two basic units from the academic session 2015-2016 as per NCTE Regulation, 2014.

- 2. **AND WHEREAS,** the ERC in its 278th meeting held on 16th 18th January, 2020 considered the matter and decided to withdraw recognition to B.Ed. course u/s 17(1) of NCTE Act 1993 from the academic session 2020-2021. Accordingly, withdrawal order was issued vide F.No.ER-278.78/WB-S/E-1/99/B.Ed./2020/62269 dated 05.02.2020 to the institution.
- 3. **AND WHEREAS,** the institution preferred an appeal to NCTE HQs. against the ERC's order dated 05.02.2020. The Appellate Authority vide order No.89-35/E-153353/2020 Appeal/10th Mtg.-2020/22nd July, 2020/92984 dated 15.09.2020 decided to remand back the case to ERC for revisiting the matter.
- 4. **AND WHEREAS**, the institution has submitted representation vide letter dated 28.09.2020 received on 05.10.2020. The ERC in its 286th meeting held on 25th & 26th November, 2020 considered the matter and as decided, Show Cause Notice was issued on 09.12.2020 to the institution.
- 5. **AND WHEREAS,** the institution submitted reply vide letters dated 26.11.2020 & 03.12.2020 received on 01.12.2020 & 07.12.2020. The original file alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and reply in response to show cause notice, were carefully considered by ERC in its 289th meeting held on 15th February, 2021 and the committee decided as under:-

"Restoration of recognition order for B.Ed. course with an annual intake of 50 (one unit) be issued.

6. **NOW, THEREFORE,** recognition withdrawn vide order No.ER-278.78/WB-S/E-1/99/B.Ed./2020/62269 dated 05.02.2020 to the institution viz. Loreto College, 7, Middleton Row, Calcutta, West Bengal-700071 (Code No. WB-S/E-1/99) for B.Ed. Course is hereby restored recognition with an annual intake of 50 (one unit).
