WHEREAS, Govt. College of Education, Banipur, 24 Parganas (North), West Bengal -743233 (Code No. WB-S/N-16/1997) was granted recognition for B.Ed. course with an annual intake of 80 vide ERC order dated 20.07.2000, followed by revised order vide No. 32327 dated 28.05.2015 with an annual intake of 50 (one basic unit of 50 students) from the academic session 2015-2016 as per NCTE Regulations, 2014.

- 2. **AND WHEREAS,** the ERC in its 284th meeting held on 17th 18th September, 2020 considered the matter and as decided, recognition granted to B.Ed. course was withdrawn u/s 17(1) of NCTE Act, 1993 from the academic session 2021-2022 vide order No.ER-284.37/(WB-S/N-16/1997) /B.Ed./2020/63162 dated 09.10.2020.
- 3. **AND WHEREAS,** the institution preferred an appeal to NCTE HQs. against the ERC order dated 28.01.2021. The Appellate Authority vide order No.89-289/E- 1172089/2020 Appeal/ 1st Mtg.-2021/18th January, 2021/97018 dated 28.01.2021 decided to remand back the case to ERC for revisiting the matter.
- 4. **AND WHEREAS**, the institution submitted representation dated 05.02.2021 received on 11.02.2021. The ERC in its 289th meeting held on 15th February, 2021, considered the matter and decided as under:

The original file along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and appeal order dated 28.01.2021 were carefully considered by ERC and the Committee decided as under:-

Restoration of recognition order of B.Ed. course with an annual intake of 50 (one unit) be issued.

5. NOW, THEREFORE, recognition withdrawn vide order No. ER-284.37/(WB-S/N-16/1997) /B.Ed./2020/63162 dated 09.10.2020. to the institution viz. Govt. College of Education, Banipur, 24 Parganas (North), West Bengal -743233 (Code No. WB-S/N-16/1997) for B.Ed. course is hereby restored recognition with an annual intake of 50 students (one unit).
