ORDER

Date:- 23rd February, 2021

WHEREAS, Bhimpur Mohanananda College of Education, Plot No.- RL 1151, 1169, 1170, 1171 Vill./P.O.-Bhimpur, Dist.-Nadia, West Bengal – 741167 (ERCAPP140) was granted recognition for B.Ed. course with an annual intake of 100 vide ERC's order dated 06.03.2012. Revised recognition order issued on 30.05.2015 with an annual intake of 100 for two basic units from the academic session 2015-2016 as per NCTE Regulation, 2014.

2. **AND WHEREAS, the ERC in its 274th meeting held on 15th – 16th July, 2019 considered the matter and decided to the intake for B.Ed. Course be reduced from 100 to 50 from the academic session 2020-2021, reduced order was issued vide F.No.ER-274.14.22/ERCAPP140/B.Ed./2019/61288 dated 20.08.2019 to the institution.**

3. **AND WHEREAS, the institution preferred an appeal to NCTE HQs. against the ERC's order dated 20.08.2019. The Appellate Authority vide order No.89-220/E-167176/2020 Appeal/29th Mtg.-2020/2nd December, 2020/95581 dated 16.12.2020 decided to remand back the case to ERC for revisiting the matter after the appellant institution submits to them copy of the faculty list approved on 30.12.2019.**

4. **AND WHEREAS, the institution has submitted representation vide letter dated 17.12.2020 received on 21.12.2020. The ERC in its 288th meeting held on 29th January, 2021 considered the matter and as decided, Show Cause Notice was issued on 05.02.2021 to the institution.**

5. **AND WHEREAS, the institution submitted reply vide letters dated 05.02.2021 received on 09.02.2021. The original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and reply in response to show cause notice, were carefully considered by ERC in its 289th meeting held on 15th February, 2021 and the committee decided as under:-**

“Restoration of recognition order for B.Ed. course to be issued for another one unit (50 intake). Hence, the total 02 units (100 intake) is permitted.

6. **NOW, THEREFORE, recognition reduced vide order. No.ER-274.14.22/ERCAPP140/B.Ed./2019/61288 dated 20.08.2019 to the institution viz. Bhimpur Mohanananda College of Education, Plot No.- RL 1151, 1169, 1170, 1171 Vill./P.O.-Bhimpur, Dist.-Nadia, West Bengal – 741167 (Code No. ERCAPP140) for B.Ed. Course is hereby restored recognition to be issued for another one unit (50 intake). Hence, the total 02 units (100 intake) is permitted.**
