WHEREAS, Dakshin Dinajpur B.Ed. College, Vill – Fulbari, P.S-Gangarampur, Dist. – Dakshin Dinjapur, West Bengal – 733140 (ERCAPP333) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2013-2014 vide ERC order dated 01.08.2013, followed by revised recognition order issued on 26.05.2015 with an intake of 100 (two basic units) from the academic session 2015-2016 as per NCTE Regulation, 2014.

2. **AND WHERAS**, the ERC in its 279th meeting held on $14^{th} - 16^{th}$ February, 2020 considered the matter and decided to withdraw recognition granted to B.Ed. course u/s 17(1) of NCTE Act 1993 from the academic session 2020-2021 to the institution. Accordingly, withdrawal order was issued vide order No. F.No.ER-279.26/ERCAPP333/B.Ed./2020/62470 dated 28.02.2020 to the institution.

3. **AND WHEREAS**, the institution preferred an appeal to NCTE HQs. against the ERC's order dated 28.02.2020. The Appellate Authority vide order No.89-90/E-157931/2020 Appeal/14th Mtg.-2020/28th July, 2020/93148 dated 15/09/2020 remanded back the case to ERC for revisiting the matter.

4. **AND WHEREAS**, the institution submitted representation vide letter dated 09.11.2020 received in this office on 10.11.2020. The original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and appeal order dated 15.09.2020, were carefully considered by ERC in 286th meeting held on $25^{th} - 26^{th}$ November, 2020 and the Committee decided as under:-

"Restoration of Recognition Order of B.Ed. course with an annual intake of 100 students (02 units) be issued".

5. NOW, THEREFORE, recognition withdrawn vide order no. F.No.ER-279.26/ERCAPP333/B.Ed./2020/62470 dated 28.02.2020 to the institution viz. Dakshin Dinajpur B.Ed. College, Vill – Fulbari, P.S-Gangarampur, Dist. – Dakshin Dinjapur, West Bengal – 733140 (Code No. ERCAPP333) for B.Ed. course is hereby restored with an annual intake of 100 students (02 units).
