ORDER

WHEREAS, Vidyasagar College of Education, Rupandighi, P.O. – Phansidewa, Dist. – Darjeeling, West Bengal - 734434 (APE00736) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2008-2009 vide ERC order dated 30.08.2008, followed by revised recognition order issued on 30.05.2015 with an intake of 100 (two basic units) from the academic session 2015-2016 as per NCTE Regulation, 2014.

- 2. **AND WHERAS**, the ERC in its 278th meeting held on 16th 18th January, 2020 considered the matter and decided to withdraw recognition granted to B.Ed. course u/s 17(1) of NCTE Act 1993 from the academic session 2020-2021 to the institution. Accordingly, withdrawal order was issued vide order No. F.No.ER-278.43/APE00736/B.Ed./2020/62263 dated 05.02.2020 to the institution.
- 3. **AND WHEREAS**, the institution preferred an appeal to NCTE HQs. against the ERC's order dated 05.02.2020. The Appellate Authority vide order No.89-46/E-154177/2020 Appeal/11th Mtg.-2020/23rd July, 2020/93020 dated 15/09/2020 remanded back the case to ERC for revisiting the matter.
- 4. **AND WHEREAS**, the institution submitted representation vide letter dated 28.09.2020 received in this office on 05.10.2020. The original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and appeal order dated 15.09.2020, were carefully considered by ERC in 286th meeting held on 25th 26th November, 2020 and the Committee decided as under:-

"Restoration of Recognition Order of B.Ed. course with an annual intake of 100 students (02 units) be issued".

5. NOW, THEREFORE, recognition withdrawn vide order no. F.No.ER-278.43/APE00736/B.Ed./2020/62263 dated 05.02.2020 to the institution viz. Vidyasagar College of Education, Rupandighi, PO – Phansidewa, Dist. – Darjeeling, West Bengal -734434 (Code No. APE000736) for B.Ed. course is hereby restored with an annual intake of 100 students (02 units).
