WHEREAS, State Institute of Physical Education for Women, Hastings House, 20B, Judges Court Road, Alipore, Kolkata, West Bengal-700027 (APE00394) was granted recognition for B.P.Ed. course with an intake of 50 vide ERC order No. 6799 dated 05.03.2007, followed by revised recognition order issued on 28.05.2015 with an intake of 100 with two sections of 50 each from the academic session 2015-2016 as per NCTE Regulation, 2014.

- 2. **AND WHERAS**, the ERC in its 279th meeting held on 14th 16th February, 2020 considered the matter and decided to withdraw recognition granted to B.Ed. course u/s 17(1) of NCTE Act 1993 from the academic session 2020-2021 to the institution. Accordingly, withdrawal order was issued vide order No. F.No.ERC-279.66/APE00394/B.P.Ed./2020/62459 dated 28.02.2020 to the institution.
- 3. AND WHEREAS, the institution preferred an appeal to NCTE HQs. against the ERC's order dated 28.02.2020. The Appellate Authority vide order No.89-136/E-160194/2020 Appeal/18th Mtg.-2020/2nd September, 2020/93746 dated 06/10/2020 decided that the appellant institution is required to submit the BCC to ERC within 15 days of the issue of appeal order. Appeal Committee further decided to remand back the case to ERC for revisiting the matter.
- 4. **AND WHEREAS**, the institution submitted representation through E-mail dated 25.11.2020. The original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and appeal order dated 06/10/2020, were carefully considered by ERC in 286^{th} meeting held on $25^{th} 26^{th}$ November, 2020 and the Committee decided as under:-

"Restoration of Recognition Order of B.P.Ed. course with an annual intake of 100 students (01 unit) be issued".

5. NOW, THEREFORE, recognition withdrawn vide order no. F.No.ERC-279.66/APE00394/B.P.Ed./2020/62459 dated 28.02.2020 to the institution viz. State Institute of Physical Education for Women, Hastings House, 20B, Judges Court Road, Alipore, Kolkata, West Bengal-700027 (Code No. APE00394) for B.P.Ed. course is hereby restored recognition with an annual intake of 100 students (01 unit).
