<u>ORDER</u>

WHEREAS, Calcutta Girls' BT College, 6/1, Swinhoe Street, Ballygunge, Dist. Kolkata, West Bengal – 700019 (Code No. WB-S/E-9/96 & APE00515) was granted recognition for B.Ed. course with an annual intake of 100 vide ERC order dated 09.02.2007, followed by revised order vide No. 32463 dated 30.05.2015 with an annual intake of 50 (one basic unit of 50 students) from the academic session 2015-2016 as per NCTE Regulations, 2014.

2. **AND WHEREAS,** the ERC in its 274th meeting held on 15th – 16th July, 2019 considered the matter and as decided, recognition granted to B.Ed. course was withdrawn u/s 17(1) of NCTE Act, 1993 from the academic session 2020-2021vide order No. ER-274.14.55/(WB-S/E-9/96 & APE00515)/B.Ed./2019/61286 dated 20.08.2019.

3. **AND WHEREAS,** the institution preferred an appeal to NCTE HQs. against the ERC order dated 20.08.2019. The Appellate Authority vide order No.89-402/E-138393/2019 Appeal/20th Mtg.-2020/4th September,2020/94744 dated 02.11.2020 decided to remand back the case to ERC for revisiting the matter.

4. **AND WHEREAS**, the institution submitted representation dated 10.11.2020 received on 16.11.2020. The ERC in its 286th meeting held on 25th - 26th November, 2020 considered the matter and as decided, show cause notice u/s 17 of NCTE Act, 1993 was issued to the institution dated 09.12.2020 on the following grounds:

- (i) The institution be asked to submit that legible copy of approved BP.
- (ii) Institution be asked to submit clarification on availability of built-up area of 735.78 Sq. Mts. as mentioned in the BCC which less as per requirement of the NCTE Regulations, 2014 as amended time to time.

5. **AND WHEREAS**, the institution submitted reply dated 22.12.2020 in response to show cause notice, received on 28.12.2020. The original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by ERC in its 288th meeting held on 29th January, 2021 and the Committee decided as under:

Restoration of recognition order of B.Ed. course with an annual intake of 50 (one unit) be issued.
