**ORDER**

**Change of Premises of the Institution**

WHEREAS, Rashtriya Sanskrit Sansthan (Deemed University), Ekalavya Campus, C/o- Swami Vivekanand Mahavidyalaya, P.O.-Fatikchara, Via-Kamalghat, Mohanpur, West Tripura, Agartala, Tripura-799210 (ERCAPP1728) granted recognition for conducting Shiksha-Shastri (B.Ed.) course of one year duration with an intake of 100 from the academic session 2014-2015 vide ERC's order No.22100 dated 30.11.2013, followed by Revised Recognition Order No.32521 dated 30.05.2015 for Shiksha-Shastri (B.Ed.) course of two year duration with an intake of 50 (one basic unit) from the academic session 2015-2016 as per NCTE Regulations, 2014.

2. **AND WHEREAS**, the aforesaid institution had submitted application dated 31.03.2016 for shifting of premises along with requisite documents.

3. **AND WHEREAS**, the ERC in its 226<sup>th</sup> meeting held on 29<sup>th</sup> -30<sup>th</sup> November, 2016 considered the matter and as decided, Show Cause Notice was issued vide No.50996 dated 17.01.2017 to the institution.

4. **AND WHEREAS**, the ERC in its 252<sup>nd</sup> meeting held on 28<sup>th</sup> February to 3<sup>rd</sup> March, 2018 considered the matter and as decided, second show cause notice was issued vide No.56480 dated 13.03.2018 to the institution.

5. **AND WHEREAS**, the ERC in its 260<sup>th</sup> meeting held on 31<sup>st</sup> August & 1<sup>st</sup> September, 2018 decided that VT be constituted for shifting of its new premises. Accordingly, inspection of the institution of new premises was conducted on 20<sup>th</sup> & 21<sup>st</sup> November, 2018 and visiting team report received at ERC, NCTE on 29<sup>th</sup> November, 2018.

6. **AND WHEREAS**, the ERC in its 264<sup>th</sup> meeting held on 05<sup>th</sup> 06<sup>th</sup> December, 2018 After considering and examining the application along with the documents submitted by the institution, agenda note, NCTE Act, NCTE Regulations 2014 including Norms and Standards, guidelines received from NCTE Hqrs. from time to time and VTR for shifting of premises, discussed the matter in detail and decided as under:

**"Shifting of the institution to its new premises, i.e. Rashtriya Sanskrit Sansthan (Deemed University), Ekalavya Campus, Old IASE Building, PO.- Kunjaban, Near Buddha Mandir, Radha Nagar, Agartala, Tripura-799006 is permitted".**

Now the institution may be run at the aforesaid address henceforth from the date of issue of this order.
