- AND WHEREAS, the ERC in its 260th meeting held on 31st August & 1st September, 2018 decided that VT be constituted for shifting of its new premises. Accordingly, inspection of the institution of new premises was conducted on 20th & 21st November, 2018 and visiting team report received at ERC, NCTE on 29th November, 2018.
- AND WHEREAS, the ERC in its 264th meeting held on 05th 06th December, 2018 After considering and examining the application along with the documents submitted by the institution, agenda note, NCTE Act, NCTE Regulations 2014 including Norms and Standards, guidelines received from NCTE Hars. from time to time and VTR for shifting of premises, discussed the matter in detail and decided as under:

"Shifting of the institution to its new premises i.e. Rashtriya Sanskrit Sansthan (Deemed University), Ekalavya Campus, Old IASE Building, PO.- Kunjaban, Near Buddha Mandir, Radha Nagar, Agartala, Tripura-799006 is permitted".
