WHEREAS, Vinoba Bhave University, Vill- Hazaribagh, Po- Sindoor, Dist-Hazaribagh, Jharkhand – 825301 was granted recognition for conducting M.Ed. course with an intake of 25 vide ERC Order No. 1364 dated 31/08/2009 from the session 2009-2010, followed by revised order vide No.32751 dated 31/05/2015 with an intake of 50 (one basic unit) from the academic session 2015-2016 as per NCTE Regulations, 2014.

- 2. AND WHEREAS, the ERC in its 279th meeting held on 14th -16th February, 2020, considered the matter and decided to issue Final Show Cause Notice u/s 17(1) of NCTE, Act 1993. Accordingly, final show cause notice was issued on 06/03/2020 to the institution on the following grounds:-
 - (i) List of teaching staff duly approved by the concerned affiliating body not submitted.
 - (ii) Blue print copy of building plan in original duly approved by the Govt. Engineer is not submitted.
 - (iii) Building Completion Certificate duly approved by the Govt. Engineer is not submitted.
 - (iv) Teaching faculty and other required documents in PDF form not uploaded & updated on institution website.
 - (v) Certified copy of registered land document to be submitted.
 - (vi) Certified copy of Fire Safety Certificate duly signed by the Govt. competent authority to be submitted.
- AND WHEREAS, the institution has submitted the reply dtd. 07/03/2020 and received in office on 12/03/2020 in response to the final show cause notice dated 06/03/2020. The original file of the institution along with other related documents, NCTE, Act.1993, Regulation & Guidelines issued by NCTE from time to time were carefully considered by ERC in its 284th meeting held on 17th 18th September,2020 and the committee was made the following observation:-
 - (i) The institution has submitted 1 +7 teaching faculty against the requirement of 10 for offering one unit of M.Ed. course as per Appendix-5 of Regulation-2014 /Norms & Standards.
 - (ii) Certified copy of Fire Safety Certificate duly signed by the Govt. competent authority is not submitted.

Hence, M.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2021-22.

- 5. **FURTHER**, if the institution is not satisfied by the order, they can prefer an appeal Under

 Section 18 of the NCTE Act in the "Online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of the issue of the order.
