<u>ORDER</u>

WHEREAS, BKJK School of Education, Plot No. 3254, 3255, Vill./P.O.-Barakulberia, Tehsil/Taluka- Barakulberia, Dist.- Nadia, West Bengal- 741150 (Code No. ERCAPP1332) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2014-2015 vide ERC Order dated 03.03.2014, followed by revised order vide No. 32140 dated 26.05.2015 with an annual intake of 100 from the academic session 2015-2016 as per NCTE Regulations, 2014.

2. AND WHEREAS, the ERC in its 279^{th} held on $14^{\text{th}} - 16^{\text{th}}$ February, 2020, considered the matter and as decided, final show cause notice u/s 17(1) was issued on 26.02.2020 to the institution on the following grounds:

- (i) Original latest faculty list duly approved by the concerned affiliating body to be submitted.
- (ii) Certified copy of registered land document to be submitted.
- (iii) Original FDRs of Rs. 5 lakh and Rs. 7 lakh to be submitted as per NCTE Regulation, 2014.
- (iv) Certified copy of Fire Safety Certificate duly signed by the Govt. competent Authority to be submitted.
- (v) Requisite information of the institutional website has not updated as per clause 7(14)(i) of the NCTE Regulation, 2014.

3. AND WHEREAS, the institution has not submitted the reply in response to final show cause notice dated 26.02.2020. The original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by ERC in its 284th meeting held on 17th & 18th September, 2020 and the committee decided as under:-

(i) Final show cause notice issued on 26.02.2020 and no reply has been received as on date.

In view of the above, the Committee decided as under:

Hence, B.Ed. Course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2021-2022.
