WHEREAS, Yogada Satsanga Palpara Mahavidyalaya, P.O.- Palpara, P.S.-Pataspur, Dist.- Purba Medinipur, West Bengal - 721458 (Code No. APE00559) was granted recognition for B.Ed. course with an intake of 100 vide ERC Order 07.02.2007, followed by revised order vide No. 32707 dated 29.05.2015 with an annual intake of 100 from the academic session 2015-2016 as per NCTE Regulations, 2014.

2. AND WHEREAS, the ERC in its 278^{th} held on $16^{th} - 18^{th}$ January, 2020 considered the matter and as decided, final show cause notice u/s 17(1) of NCTE Act, 1993. Accordingly final show cause was issued on 28.01.2020 to the institution on the following grounds:

- a) Latest original faculty list as per NCTE Regulation, 2014 to be submitted. However, staff already resigned need to be appointed/replaced within the prescribed proforma.
- b) Registered land document duly attested by the competent authority to be submitted.
- c) Building plan (BP) duly signed by the competent authority to be submitted.
- d) Building Completion Certificate (BCC) duly signed by the competent authority has not submitted.
- e) Original FDRs of Rs. 5 lakh and Rs. 7 lakh to be submitted.
- f) Certificate copy of Fire Safety Certificate duly signed by the Govt. competent Authority to be submitted.

3. AND WHEREAS, the ERC in its 284^{th} meeting held on $17^{\text{th}} - 18^{\text{th}}$ September, 2020, considered the matter along with the reply dated 24.02.2020 & 12.09.2020 received in this office on 27.02.2020 & 15.09.2020 submitted by the institution in response to Final Show Cause Notice and observed as under:-

(i) Renewal copy of Fire Safety Certificate is not submitted as the validity of Fire Safety Certificate expired on 07.04.2020.

In view of the above, the Committee decided as under:

Hence, B.Ed. Course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2021-2022.

4. NOW THEREFORE, recognition granted to the institution viz. Yogada Satsanga Palpara Mahavidyalaya, P.O.- Palpara, P.S.- Pataspur, Dist.- Purba Medinipur, West Bengal - 721458 (Code No. APE00559) for B.Ed. Course is hereby withdrawn under section 17(1) of NCTE Act, 1993 with effect from the academic session 2021-2022.
