ORDER

WHEREAS, Govt. Teachers Training College, Hazaribagh, Jharkhand- 825301 was granted recognition for B.Ed. Course with an intake of 100 from the academic session 2002-2003 vide ERC Order vide No.1846 dated 20.06.2002, followed by revised recognition order vide No.32741 dt. 31.05.2015 with an annual intake of 100 (Two Basic Units) from the academic session 2015-2016 as per NCTE Regulations, 2014.

- AND WHEREAS, the ERC in its 284th meeting held on 17th-18th September, 2020, decided that recognition granted to B.Ed. course be withdrawn from the academic session 2021-2022 on the grounds mentioned therein. Accordingly, withdrawal order issued vide No.63115 dt. 05.10.2020.
- AND WHEREAS, institution preferred appeal against the withdrawal order at NCTE HQrs. and the Appellate Authority vide order F.No.89-273/E-171342/2020 Appeal/1st Mtg-2021/18th January, 2021/97014 dated 28.01.2021 remanded back the case with a direction to consider the documents furnished in appeal, to be submitted to them by the appellant, and take further necessary action as per the NCTE Regulations, 2014. The appellant was directed to forward to the ERC all the documents submitted in appeal, with originals thereof, wherever necessary, within 15 days of receipt of orders on the appeal.
- AND WHEREAS, the ERC in its 289th meeting held on 15th February, 2021 considered the original file alongwith other related documents, NCTE Act. 1993, Regulations and Guidelines issued by NCTE from time to time and accordingly, show cause notice vide no.63610 dated 18.02.2021 was issued to the institution on the ground mentioned therein.
- AND WHEREAS, the ERC in its 290th meeting held on 3rd March, 2021 considered the original file 5. alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, reply in response to show cause notice and as decided by ERC, a clarification letter vide no.63728 dated 05.03.2021 was issued to the institution to submit certified copy of Fire Safety Certificate duly signed by the Govt. Competent Authority within 30 days from the date of issue of letter.
- AND WHEREAS, the ERC in its 292nd meeting held on 20th April, 2021 considered the original file alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, reply in response to clarification letter and as decided by ERC, another clarification letter vide no. 64049 dated 29.04.2021 was issued to the institution to submit valid fire safety certificate issued by the competent Govt. Authority within 30 days from the date of issue of letter.
- 7. **AND WHEREAS,** the ERC in its 298th (Emergent) meeting held on 05th November, 2021 considered the original file alongwith other related documents, NCTE Act 1993, Regulations and Guidelines issued by NCTE from time to time, reply in response to clarification letter and the Committee made following observations:

"Restoration of recognition order for B.Ed. conse with an annual intake of 100 (two units) be issued."
