ORDER

Whereas, the institution, Moulana Abul Kalam Ajad Teachers Training Institute, Plot No-2038 & 2092, Vill./P.O-Bhedia, Tehsil/Taluka-Bhedia, Dist-Bardhaman, West Bengal-713126 (File Code No. ERCAPP457) was granted recognition vide ERC (NCTE) order No.13621 dtd. 24.08.2012 for conducting B.Ed. Course of one year duration with an annual intake of 100 students from the academic session 2008-2009.

- 2. AND WHEREAS on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dt. 19.01.2015 for its willingness of Two basic units in B.Ed. course and adherence of provisions of new Regulations.
- 3. AND WHEREAS, provisional revised recognition order was not issued to the institution on 27.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 students from the academic session 2015-2016.
- 4. AND WHEREAS, the compliance was not submitted by the institution considered by the ERC in its 267^{th} Meeting held on $10^{th} 11^{th}$ February, 2019 and as decided to issue the show cause notice u/s 17(1) on 21.02.2019 to the institution.
- 5. AND WHEREAS, the ERC in its 274^{th} Meeting held on $15^{th} 16^{th}$ July. 2019, considered the matter along with the reply received on 18.03.2019 submitted by the institution in response to SCN dtd. 21.02.2019 and decided to issue the Final Show Cause Notice u/s 17(1) dtd. 11.09.2019.
- 6. **AND WHEREAS**, the FRC in its 279th Meeting held on 14th 16th February 2020 considered the matter along with the reply received on 23.09.2019 submitted by the institution in response to Final Show Cause Notice and decided as under:-
 - Teaching faculty mentioned at Sl. No. 1, 4 & 16 do not possess requisite qualification & Parttime teacher is not Permitted as per regulation 2014 & amendment.
 - There is mismatch of built up area in both Building Plan (BP) & Building Completion Certificate (BCC).

Hence, B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2020-21.

7. AND WHEREAS, the institution has submitted the representation dtd. 25.02.2020, which has placed before the ERC in its 280th Meeting held on 29th February & 1st March, 2020 and decided as under:

Decision of 279th meeting for withdrawal of the recognition stand cancelled. Accordingly, Continuation of Revised Recognition Order (RRO) be issued.

- 8. Now Therefore, the ERC decided to permit the institution i.e. Moulana Abul Kalam Ajad Teachers Training Institute, Plot No-2038 & 2092, Vill./P.O-Bhedia, Tehsil/Taluka-Bhedia, Dist-Bardhaman, West Bengal-713126 for continuation of recognition for B.Ed. course of two-years duration with an intake of 100 students (Two basic units) subject to fulfilment of the following conditions:
 - a) The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - b) The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
 - c) The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
 - d) The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
 - e) The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 8. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, the State Government etc. as applicable.
- 9. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 10. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
 - a) Sanctioned programme(s) along with annual intake in the institution.
 - b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c) Name of faculty members who left of joined during the last, quarter:
 - d) Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
 - e) Free charged from students.
 - f) Available infrastructural facilities.
 - g) Facilities added during the last quarter;
 - h) Numbers of books in the library, journals subscribed to and additions, if any, in the last quarter;
 - i) The affidavit with enclosure submitted along with application.
 - j) The institution shall be free to post additional relevant information, if it so desires.
 - k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

- 12. The institution shall make available the list of students admitted on its officials website.
- 13. The institution shall fill the information on GIS Portal on the NCTE Website.
- 14. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Eastern Regional Committee under the provisional of Section 17(21) of the NCTE Act, 1993.
