### **ORDER**

WHEREAS, Mahatma Buddha Teachers Training College, Plot No.1775, Vill-Dhrub Nagar, Panchmile, Po-Kamaldah, Tehsil/Taluka-Bathnaha, City/Dist-Sitamarhi, Bihar-843322 was granted recognition for B.Ed. Course with an annual intake of 100 vide ERC Order No.13890 dated 31.08.2012 from the academic session 2012-2013, followed by revised recognition order vide No.31641 dt.13.05.2015 with an annual intake of 100 (Two Basic Units) from the academic session 2015-2016 as per NCTE Regulations, 2014.

- 2. AND WHEREAS, the ERC in its 283<sup>rd</sup> meeting held on 24<sup>th</sup>-25<sup>th</sup> August, 2020, decided that recognition granted to B.Ed. course be withdrawn from the academic session 2021-2022. Accordingly, withdrawal order issued vide No.63029 dt.15.09.2020.
- 3. AND WHEREAS, institution preferred appeal against the withdrawal order at NCTE HQrs. and the Appellate Authority vide order 89-267/E-170699/2020 Appeal/3<sup>rd</sup> Mtg.-2021/20<sup>th</sup> January, 2021/97363 dated 11.02.2021 considered the matter and remanded back the case to ERC with a direction to consider specific and pointed replies to the grounds of withdrawal to be submitted to the ERC by the appellant, duly supported by documents, with originals thereof, wherever necessary, within 15 days of receipt if orders on the appeal and take further necessary action as per the NCTE Regulation, 2014. The appellant is directed to forward to the ERC their specific replies as mentioned above within the time frame set above. As per direction of the Appellate Authority, Institution submitted its representation dt.19.02.2021 received on 25.02.2021.
- 4. AND WHEREAS, the ERC in its 290<sup>th</sup> meeting held on 03<sup>rd</sup> 04<sup>th</sup> March, 2021, decided to issue Show Cause Notice to the institution. Accordingly, Show Cause Notice issued to the institution on dt.08.03.2021. In response to Show Cause Notice institution submitted its representation dt.20.03.2021 received on 30.03.2021.
- 5. AND WHEREAS, the ERC in its 292<sup>nd</sup> meeting held on 20<sup>th</sup> April, 2021 considered the original file along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and reply in response to show cause notice were carefully considered by the ERC and Committee decided as under:-

Restoration of recognition order for B.Ed. course with an annual intake of 100 (two units) be issued.

6. NOW THEREFORE, withdrawal order dated 15.09.2020 issued to the institution viz. Mahatma Buddha Teachers Training College, Plot No.1775, Vill-Dhrub Nagar, Panchmile, Po-Kamaldah, Tehsil/Taluka-Bathnaha, City-Dist-Sitamarhi, Bihar-843322 for B.Ed. course is hereby restored permitting the total annual intake of 100 (two basic units).
