ORDER

WHEREAS, Muktir Shiksha College of Education, Plot No.- 1180, 1181, 1182, Vill.-Kuchlia, PO.- Gobardanga, Tehsil/Taluka-Kuchlia, Town/City-Gobardanga, Dist-North 24 Parganas, West Bengal-743235 (Code No.ERCAPP2921) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2017-2018 vide ERC order dated 27/12/2016, followed by revised order vide No. 57808 dated 28/08/2018 with an annual intake of 50 from the academic session 2018-2019 as per NCTE Regulations, 2014.

- 2. **AND WHEREAS**, the institution preferred an appeal to NCTE HQs. against the ERC's order dated 28/08/2018 for reduced the annual intake form 100 to 50. The Appellate Authority vide order No. 89-296/E-172648/2020 Appeal/4th Mtg.2021/21st January, 2021/97573 dated 15/02/2021. The Appeal Committee concluded that the case of appellant institution deserves to be revisited keeping in view the review lists of faculty dated 08.06.2017 and 22.12.2017 submitted by appellant to ERC.
- 3. **AND WHEREAS**, the ERC in its 290th meeting (Part-1) held on 3rd March, 2021 considered the appeal order dated 15/02/2021 and considered matter and as decided to issue a clarification letter to the institution to submit reply within 30 days from the date of issue of letter. Accordingly, a clarification letter issued to the institution on 16/03/2021 on the following ground:
 - a) Principal viz. Dr. Karanam Mahaboob Vali appointed on 22.12.2017 is having Ph. D (Education) with 61% as reflected in the approved faculty list submitted by the institution. Hence, Ph.D. degree with percentage of marks need to be clarified.
- 4. **AND WHEREAS**, the institution submitted reply dated 04.03.2021 received in this office on 08.03.2021 & 15.03.2021. The ERC in its 292nd meeting held on 20th April, 2021 considered the matter and decided as under:

"The original file along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and reply in response to clarification letter were carefully considered by the ERC and Committee decided as under

Restoration of recognition for additional intake of 50 withdrawn from the academic session 2018-2019 vide order No.57808 dated 28.08.2018 be issued, making the total intake of 100 (two units)."
