## ORDER

WHEREAS, Model B.P.Ed. College, Beguntary, P.O.-Kharia, Vill.- College Para, Dist.- Jalpaiguri, West Bengal-735101 (Code No. APE00622) was granted recognition for B.P.Ed. course with an annual intake of 50 vide ERC's order dated 28.02.2008, followed by revised recognition order issued on 29.05 .2015 for one basic unit of 100 students with two sections of 50 each from the academic session 2015-2016 as per NCTE Regulation, 2014.
2. AND WHEREAS, the ERC in its $283^{\text {rd }}$ meeting held on $24^{\text {th }}-25^{\text {th }}$ August, 2020 considered the matter and decided to withdraw recognition $\mathrm{u} / \mathrm{s} 17$ (1) of NCTE Act 1993 from the academic session 2021-22. Accordingly, withdrawal order was issued vide. F.No : ER283.30/APE00622/B.P.Ed./2020/62984 dated 07/09/2020 to the institution.
3. AND WHEREAS, the institution preferred an appeal to NCTE HQs. against the ERC's order dated 07/09/2020. The Appellate Authority vide its order No.89-236/E-168246/2020 Appeal/30 ${ }^{\text {th }}$ Mtg.-2020/3 $3^{\text {rd }}$ December, 2020/95786 dated 21/12/2020 has remanded back the case to ERC with a direction to consider documents, to be submitted by the appellant, and take further necessary action as per the NCTE Regulation, 2014. The appellant is directed to forward to the ERC all the documents submitted in appeal within 15 days of issue of orders on the appeal.
4. AND WHEREAS, the institution submitted its reply vide letter dated 24.12.2020. The ERC in its $288^{\text {th }}$ meeting held on $29^{\text {th }}$ January, 2021 considered the matter and as decided, Show Cause Notice under section 17 of NCTE Act, 1993 issued to the institution. Accordingly, show cause notice was issued to the institution on 05.02.2021.
5. AND WHEREAS, the institution submitted reply vide letters dated 31.03.2021 received on 05.04.2021. The ERC in its $292^{\text {nd }}$ meeting held on $20^{\text {th }}$ April, 2021 considered the matter and decided as under:-
"The original file alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and reply in response to show cause notice were carefully considered by the ERC and Committee decided as under:-
