ORDER

WHEREAS, Dept. of Education, Dibrugarh University, Dibrugarh, Assam– 781 316 (File No. AS-S/E-1/96) was granted recognition for B.Ed. course with an intake of 60 from the academic session 1996-1997 vide ERC Order No.283 dated 05.02.2001, followed by revised order vide No. 31954 dated 23.05.2015 with an annual intake of 50 from the academic session 2015-2016 as per NCTE Regulations, 2014.

2. AND WHEREAS, the ERC in its 279th held on 14th – 16th February, 2020 considered the matter and as decided, Final Show Cause Notice u/s 17(1) was issued on 05.03.2020 to the institution on the following grounds:

- (i) Approved faculty list (current) by the concerned affiliating body along with requisite documents.
- (ii) Approved building plan by the concerned competent Govt. Engineer/Authority.
- (iii) Approved building completion certificate by the concerned competent Govt. Engineer/Authority.
- (iv) FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.
- (v) Confirmation on website updates of the institutions with all details along with affidavit.
- (vi) Certified copy of registered land document to be submitted.
- (vii) Certified copy of Fire Safety Certificate duly signed by the Govt. competent authority to be submitted.


3. AND WHEREAS, the ERC in its 282nd meeting held on 8th & 9th July, 2020 considered the matter along with the reply dated 13.02.2020 & 13.03.2020 received in this office on 17.02.2020 & 18.03.2020 submitted by the institution in response to Final Show Cause Notice and observed as under:-

- a) No separate faculty list for B.Ed. course duly approved by Registrar of the concerned affiliating body submitted.
- b) Certificate copy of Fire Safety Certificate duly signed by the Govt. competent Authority is not submitted.

In view of the above, the Committee decided as under:

Hence, B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2021-2022.




