WHEREAS, Govt. B.Ed. Training College, Plot No.- 1-9, Vill.- Duguripari, Kalinga, Tehsil/Taluka- G.Udaygiri, Town/City- Kalinga, Dist.- Kandhamal, (Code No. ERCAPP941) was granted recognition for conducting B.Ed. course of one year duration with an intake of 100 from the academic session 2012-2013 vide ERC's order No. 13263 dated 13.08.2012.

- 2. AND WHEREAS, Revised Recognition Order (RRO) was issued for conducting B.Ed. course of two years duration with an intake of 100 from the academic session 2015-2016 vide ERC's No. F. ERC/NCTE/ERCAPP941/B.Ed.(Revised Order)/2015/32699 dated 31.05.2015 as per NCTE Regulation, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.
- 3. **AND WHEREAS,** a Public Notice was uploaded on ERC's website on 30.01.2018, wherein 138 TEIs have not furnished their compliance reports in respect of conditions mentioned in the Revised Recognition Orders issued on or before 31st May, 2015 on the basis of implementation of NCTE Regulations, 2014. The ERC in its 254th meeting held on 16th 17th April, 2018 considered the matter and decided, 1st Show Cause Notice was issued on 20.04.2018 to the institution on the following grounds:
 - a. Approved faculty list (current) by the concerned affiliating body along with requisite documents.
 - b. Approved building plan by the concerned competent Govt. Engineer/Authority.
 - c. Approved building completion certificate by the concerned competent Govt. Engineer/Authority.
 - d. FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.
 - e. Confirmation on website updates of the institutions with all details along with affidavit.
- 4. **AND WHEREAS**, the institution submitted reply vide letter dated 04.05.2018, received in ERC, NCTE on 05.02.2020. The ERC in its 280th meeting held on 29th February to 1st March, 2020 considered the matter and decided, Final Show Cause Notice was issued on 03.03.2020 to the institution on the following grounds:-
 - (i) Faculty list duly signed by the concerned affiliating body in the prescribed proforma to be submitted.
 - (ii) Blue print of Building Plan (BP) mentioning the Plot No./khasra No., total land area & Built up area etc. not duly signed by the competent authority.

- 5. **AND WHEREAS**, the institution submitted reply vide letter dated 10.06.2020, received in ERC, NCTE on 15.06.2020. The ERC in its 282nd meeting held on 08th 09th July, 2020 considered the original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and observed as under:-
 - (i) List of teaching faculty member is less against the requirement of I+15 for running two units of B.Ed. course as per Appendix-4 of NCTE Regulation, 2014.

(ii) Building Plan (BP) has not been duly signed by the competent authority.

Hence, B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2021-22.

- 6. NOW THEREFORE, recognition granted to the institution viz. Govt. B.Ed. Training College, Plot No.- 1-9, Vill.- Duguripari, P.O.- Kalinga, Tehsil/Taluka- G.Udaygiri, Town/City- Kalinga, Dist.-Kandhamal, Odisha- 762001 (Code No. ERCAPP941) for B.Ed. Course is hereby withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2021-2022.
