WHEREAS, T P College, Madhepura, Plot No.1769, Street/Road-Madhepura, Vill/Po-City-Madhepura, Tehsil/Taluka-Madhepura, Dist-Madhepur, Bihar-852113 was granted recognition for B.Ed. Course with an intake of 100 vide ERC Order No.23870 dated 12.02.2014, followed by revised recognition order No.31660 dt.15.05.2015 with an intake of 100 (Two Basic Units) from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

- 2. AND WHEREAS, as per decision of the ERC taken in its 278th meeting held on 16th–17th January, 2020, the recognition of the institution was withdrawn from the academic session 2020-2021. Accordingly, withdrawal order No.61196 dt.05.08.2019 was issued to the institution.
- 3. AND WHEREAS, the institution preferred an appeal to the NCTE Hqrs. against the refusal order of ERC. The appellate authority vide order No.89-368/E-135957/2019 Appeal/ 20th Mtg. 2020/4th September, 2020/94724 dt.02.11.2020 decided that appellant institution is required to submit original faculty list, FDRs, copies of the Building Plan, Building Completion Certificate and printout of web pages to ERC. The above documents should be submitted to ERC within 15 days of the issued of appeal order. Appeal Committee further decided to remand back the case to ERC for tevisiting the matter.
- 4. AND WHEREAS, the ERC in its 286th meeting held on 25th & 26th November, 2020 considered the original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and appeal order dated 02.11.2020, and decided as under:-

Restoration of recognition order of B.Ed. course with an annual intake of 100 students (02 unit) be issued.

5. NOW THEREFORE, recognition withdrawn vide order dated 05.08.2019 to the institution viz. T P College, Madhepura, Plot No.1769, Street/Road-Madhepura, Vill/Po/City-Madhepura, Tehsil/Taluka-Madhepura, Dist-Madhepur, Bihar-852113 for B.Ed. course is hereby restored.
