### **ORDER**

WHEREAS, Parwati Science College, Kriti Nagar, Madhepura, Plot No-1818, 1819, 1822, 1840-1841, Vill/Po-Madhepura, Tehsil/Taluka- Madhepura, Dist-Madhepura, Bihar-852113 was granted recognition for B.Ed. Course with an intake of 100 vide ERC Order No.16127 dated 05.02.2013, followed by revised recognition order No.31842 dt.22.05.2015 with an intake of 100 (Two Basic Units) from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

- 2. AND WHEREAS, as per decision of the ERC taken in its 280<sup>th</sup> meeting held on 29<sup>th</sup> February 01<sup>st</sup> March, 2020, the recognition of the institution was withdrawn from the academic session 2020-2021. Accordingly, withdrawal order No.62593 dt.06.03.2020 was issued to the institution.
- 3. AND WHEREAS, the institution preferred an appeal to the NCTE Hqrs. against the refusal order of ERC and the Appellate Authority vide order No.89-89/E-157935/2020 Appeal/14<sup>th</sup> Mtg. 2020/28<sup>th</sup> July, 2020/93144 dt.15.09.2020 remanded back the file to the ERC for revisiting the matter and Appeal Committee decided that appellant institution is required to submit to ERC within 15 days of the issue of appeal order the following documents (i) Original list of faculty approved by affiliating university, (ii) Printout of updated website.
- 4. AND WHEREAS, the ERC in its 286<sup>th</sup> meeting held on 25<sup>th</sup> & 26<sup>th</sup> November, 2020 considered the original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and appeal order dated 15.09.2020, and decided as under:-

Restoration of recognition order of B.Ed. course with an annual intake of 100 students (02 unit) be issued.

5. NOW THEREFORE, recognition withdrawn vide order dated 06.03.2020 to the institution viz. Parwati Science College, Kriti Nagar, Madhepura, Plot No.1818, 1819, 1822, 1840-1841, Vill/Po-Madhepura, Tehsil/Taluka-Madhepura, Dist-Madhepura, Bihar-852113 for B.Ed. course is hereby restored.
