ORDER

WHEREAS, Maulana Azad National Urdu University, Plot No.2, Khasra No.1851, PO-Chandanpatti, Tehsil/Taluka-Bahadurpura, Town/City-Darbhanga, Dist-Darbhanga, Bihar-846001 was granted recognition for M.Ed. Course with an intake of 35 vide ERC Order No.23974 dated 19.02.2014, followed by revised recognition order No.32523 dt. 30.05.2015 with an intake of 50 (One Basic Unit) from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfillment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

- 2. AND WHEREAS, as per decision of the ERC taken in its 274^{th} meeting held on $15^{th} 16^{th}$ July, 2019, the recognition of the institution was withdrawn from the academic session 2020-2021. Accordingly, withdrawal order No.61139 dt.05.08.2019 was issued to the institution.
- AND WHEREAS, the institution preferred an appeal to the NCTE Hqrs. against the wishdrawal order of ERC. The appellate authority order No.89-380/E-136573/2019 Appeal/20th Mtg.-2020/4th September, 2020/94728 dt.02:11.2020 noted that appellant university is a Central University conducting M.Ed. programme since 2014. Appellant University is dependent on U.G.C. for creation of posts. Appeal Committee noted the oral request made by appellant assuring that deficiency of one Professor will be met before start of the academic session and till such a time the vacancy of Professor is filled up, Principal of the CTE who is of the rank of Professor will be utilised as per academic needs. Appeal Committee decided that appellant institution is required to submit to ERC, within 15 days of issue of appeal order, list of faculty in original. Appeal Committee further decided to remand back the case to ERC for revisiting the matter.
- 4. AND WHEREAS, the ERC in its 286th meeting held on 25th & 26th November, 2020 considered the original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and appeal order dated 02.11.2020, and decided as under:-

Restoration of recognition order of M.Ed. course with an annual intake of 50 students (01 unit) be issued.

- 5. NOW THEREFORE, recognition withdrawn vide order dated 26.02.2020 to the institution viz. Maulana Azad National Urdu University, Plot No.2, Khasra No.1851, PO-Chandanpatti, Tehsil/Taluka-Bahadurpura, Town/City-Darbhanga, Dist-Darbhanga, Bihar-846001 for M.Ed. course is hereby restored.
- 6. The terms and conditions of the order No.32523 dt.30.05.2015 issued to the institution shall remain same.
