#### **ORDER**

WHEREAS, Sikkim Govt. B.Ed. College, Vill./PO - Soreng, Tehsil/Taluka - Soreng, Dist - West Sikkim, Sikkim was granted recognition for B.Ed. Course with an intake of 100 vide ERC Order No. ERC/7-10292S).5(I).1/2009/2062 dated 19.11.2009 from the academic session 2009-2010, followed by revised recognition order No. 32640 dt. 31.05.2015 with an intake of 100 (two basic units) from the academic session 2015-2016 as per NCTE Regulations, 2014. Again, permission granted to additional intake of 50 (ID No. 7541), thus total intake 150 from the academic session 2017-2018 vide order dated 02.05.2017.

- 2. **AND WHEREAS**, the ERC in its 274<sup>th</sup> meeting held on 15<sup>th</sup> 16<sup>th</sup> July, 2019 considered the matter and observed that 1<sup>st</sup> show cause notice u/s 17(1) issued on 20.04.2018. Final show cause notice issued dated 16.05.2019 and the institution is still deficient on the following ground:
  - i) Faculty list comprises 1+14 as against the requirement of 1+22 as per NCTE Regulations, 2014 for running 150 intake of B.Ed. course.

Out of total intake 150 granted to B.Ed. course one unit (50 intake) be reduced from the academic session 2020-2021 with intimation to the institution and all concerned.

- 3. AND WHEREAS, the institution preferred an appeal to the NCTE Hqrs. against the ERC's order dated 21.08.2019. The Appellate Authority vide its Order No. 89-51/E-154611/2020 Appeal/21<sup>st</sup> Mtg.-2020/7<sup>th</sup> September, 2020/93622 dated 05.10.2020 decided that appellant institution is required to submit original of the list containing the names of Principal and 22 faculty to ERC within 15 days of the issue of appeal order. Appeal Committee further decided to remand back the case to ERC for revisiting the matter for restoring the full intake of B.Ed. programme.
- 4. **AND WHEREAS**, the ERC in its 286<sup>th</sup> meeting held on 25<sup>th</sup> & 26<sup>th</sup> November, 2020 considered the original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and appeal order dated 05.10.2020, and decided as under:-

Restoration of recognition order of B.Ed. course with an annual intake of 150 students (03 units) be issued.

- NOW THEREFORE, recognition reduced vide order dated 21.08.2019 to the institution viz. Sikkim Govt. B.Ed. College, Vill./PO - Soreng, Tehsil/Taluka - Soreng, Dist - West Sikkim, Sikkim for B.Ed. course is hereby restored, to an annual intake of 150 students (03 units).
- 6. The terms and conditions of the order F. No. ER-239.6.62(part-2)/ID No. -7541/B.Ed. (Addl. Intake)/2017/52909 dt. 02.05.2017 issued to the institution shall remain same.
