
**ORDER**

**WHEREAS**, in terms of Section 14/15 of the NCTE Act, 1993, Solanki B.Ed. Teacher Training College, Moti Nagar, Bara Telpa, P.O.-Chapra, District-Saran, Bihar Pin Code-841301 was granted recognition for B.Ed. Course of one year duration with an intake of 100 vide ERC Order No.ERC/7-104.4(1).2/2010/3224 dated 30.01.2010, followed by revised recognition for B.Ed. course of two years duration with an intake of 100 students (two basic unit) from the academic session 2015-2016 vide order ERC/NCTE/APE00829/B.Ed.(Revised Order)/2015/32538 dt.30.05.2015, as per NCTE Regulations, 2014.

2. **AND WHEREAS**, the ERC in its 255<sup>th</sup> meeting held on 30<sup>th</sup> April to 2<sup>nd</sup> May, 2018 considered the compliance report received in response to revised recognition order, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time and accordingly as decided by the Committee, show cause notice under section 17(1) of NCTE Act, 1993 issued vide no.57026 dated 17.05.2018 to the institution with direction to submit reply within 21 days on the following grounds:

- Faculty list duly approved by the concerned affiliating body not submitted
- FDRs towards Endowment and Reserve fund after conversion into joint mode not submitted.
- Converted FDRs in joint operation mode is required to be uploaded on institution website.
- Blue print of building plan in original duly approved by the Govt. Engineer is not submitted.
- Building completion certificate duly approved by the Govt. Engineer is not submitted.
- Website not maintained and updated.

3. **AND WHEREAS**, the ERC in its 278<sup>th</sup> meeting held on January 16-18, 2020 considered the representation in response to show cause notice and accordingly as decided by the Committee, final show cause notice under section 17(1) of NCTE Act, 1993 issued vide no.62163 dated 28.01.2020 to the institution with direction to submit reply within 21 days on the following grounds:

- i. Latest original list of teaching faculty duly approved by the affiliating body to be submitted.
- ii. Teaching faculty mentioned at Sl. No.2, 3, 4 & 14 is mismatched when compared with the website uploaded by the institution.
- iii. Original FDRs of Rs.5 lakh and Rs.7 lakh to be submitted.
- iv. Certified copy of Fire Safety Certificate duly signed by the Govt. competent Authority to be submitted.
- v. Requisite information of the institutional website has not updated as per clause 7(14)(i) of the NCTE Regulation, 2014.

4. **AND WHEREAS**, the ERC in its 280<sup>th</sup> meeting held on January 29<sup>th</sup> February and 1<sup>st</sup> March, 2020 considered the representation in response to final show cause notice and accordingly as decided by the Committee, recognition granted to B.Ed. course be withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021 on the following grounds:

- i. Teaching faculty mentioned at Sl.No.10, 12, & 13 do not possess NET/Ph.D. qualification as per amendment Gazette Notification dated 09.06.2017.
- ii. Music and Fine Arts members of Teaching faculty have not appointed as prescribed in Appendix-4 of NCTE Regulation, 2014.

Accordingly, withdrawal order vide no. 62594 dated 06.03.2020 was issued to the institution.

5. **AND WHEREAS**, the institution being aggrieved with ERC's withdrawal order dated 06.03.2020 filed L.P.A-117 of 2021 in the Hon'ble High Court of Judicature at Patna, which passed an order dated 16.09.2021 directing to carry out the inspection and thereafter pass an appropriated order, positively, within a period of four weeks from today. Shri Singh, learned Senior Counsel for the appellant states that within next two working days the appellant shall file an appropriate application and comply with all requirements so required, for carrying out the inspection.

6. **AND WHEREAS**, the ERC in its 296<sup>th</sup> (Emergent) Meeting held on 01.10.2021 considered the original file along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time, the order dated 16.09.2021 passed by the Hon'ble High Court of Patna in L.P.A.-117/2021 and the Committee decided that the Visiting Team (VT) to be constituted under section 14 of the NCTE Act, 1993 to ascertain infrastructure instructional facilities of the TEI.

7. **AND WHEREAS**, inspection of the institution has been conducted on 04.12.2021 & 05.12.2021 and the hard copy of visiting team report received on 11.12.2021.

8. **AND WHEREAS**, the ERC in its 300<sup>th</sup> ERC (Virtual) Meeting held on 28<sup>th</sup> December, 2021 considered the original file alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, visiting team report and the Committee made following observations:

“The institution is still deficient on the following in light of NCTE Regulations, 2014:

- i. Notarised copy of the Building Completion Certificate not submitted.
- ii. The Validity of FDRs of Rs. 5+3 lakhs have been expired since 30.05.2019 and 31.05.2019 respectively. Renewed copies of bank authorization letter in Form ‘A’ related to FDRs not submitted. The institution is required to submit original valid FDRs of Rs. 5.00 lakh towards Endowment Fund and Rs 7.00 lakh towards Reserve Fund in joint mode along with bank as per Clause 10(1) of NCTE Regulations, 2014.
- iii. Copy of faculty list submitted by the institution is not approved by the Affiliating University and not in accordance with NCTE prescribed proforma. Copy of faculty list submitted earlier does not match with list attached with VT report.
- iv. An original affidavit on Rs.10/- non judicial stamp paper by individual faculty (newly appointed) along with educational and professional certificate is not submitted.
- v. Size of multipurpose hall is less than the requirement of 2000 sq. ft. as per NCTE norms.

Accordingly, as decided by the Committee, Show Cause notice u/s 14(3)(b) issued vide No.64847 dated 31.12.2021 with direction to the institution to comply above deficiencies within 30 days from the date of issue of show cause notice.


9. **AND WHEREAS**, the ERC in its 302<sup>nd</sup> (Virtual) meeting held on 28<sup>th</sup> February & 01<sup>st</sup> March, 2022 considered the original file alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, representation from the institution in response to Show Cause Notice and the Committee made following observations:

“The institution has submitted a copy of faculty list comprising 01 (Principal) + 15 faculty approved by Registrar of affiliating body, J.P. University dated 14.01.2022, without reflecting the attested copies of photographs of teaching staff (required as per NCTE prescribed proforma) in the faculty list. The list of approved faculty in NCTE prescribed proforma showing all details is required to be uploaded on institutional website.

Hence, final show cause notice under section 17(1) of the NCTE Act, 1993 be issued to the institution to submit reply within 30 days from the date of issue of show cause notice with direction to update the revised staff profile in ERC portal of NCTE website as required under NCTE Regulations.”

Accordingly, final show cause notice dated 08.03.2022 issued to the institution.

10. **AND WHEREAS**, the ERC in its 305<sup>nd</sup> (Virtual) meeting held on 28<sup>th</sup> April, 2022 considered the original file alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, representation from the institution in response to final Show Cause Notice u/s 17 of NCTE Act, 1993 and the Committee decided as under:

**“The restoration of recognition order to the institution viz. Solanki B.Ed. Teachers Training College, At – Moti Nagar, Bara Telpa, PO – Chapra, Dist – Saran, Bihar – 841301 for B.Ed. course with annual intake of 100 students (02 units) be issued.”**

11. **NOW THEREFORE, withdrawal order dated 06.03.2020 issued to the institution viz. Solanki B.Ed. Teacher Training College, Moti Nagar, Bara Telpa, P.O.-Chapra, District-Saran, Bihar Pin Code-841301 for B.Ed. Course is hereby restored with annual intake of 100 students (02 units).**

12. Further, if the institution is not satisfied by the order, they can prefer an appeal under Section 18 of the NCTE Act, 1993 in the “Online mode” available on NCTE’s website [www.ncte.gov.in](http://www.ncte.gov.in) within 60 days from the date of the issue of the order.
