WITHDRAWAL ORDER

WHEREAS, in terms of Section 14/15 of the NCTE Act, 1993, Bishnupur Mallabhum B.Ed. College, Plot No.- 330, Vill - Mayrapukur, P.O.-Gossainpur, Tehsil/Taluka – Bishnupur, Town/ City - Bishnupur, Dist - Bankura, West Bengal - 722122 was granted recognition for B.Ed. programme of two year duration with an annual intake of 50 seats *vide* ERC Order ERC/218.6.17/ERCAPP3825/B.Ed./ 2016/48609 dated 29.07.2016, followed by order for an additional intake of 50 students thereby making an annual intake of 100 students from the academic session 2016-2017 *vide* Order No. F.No.ER-236.4.6 (Part-II)/ERCAPP3825/B.Ed./2016/52601 dated 28.04.2017, as per NCTE Regulations, 2014.

2. AND WHEREAS, the matter was placed before ERC in its 307th (Virtual) meeting held on 05th August, 2022 and the committee decided to issue Show Cause Notice to the institution. Accordingly, SCN was issued to the institution on 12.08.2022. The reply of the institution was received in ERC on 07.09.2022, 06.10.2022 and 23.03.2023.

3. AND WHEREAS, the matter was placed before ERC in its 319th (Virtual) meeting held on 25th January, 2023 and the committee considered the reply submitted by the institution in reference to the Show Cause Notice and decided to get verified the following documents from the concerned issuing authorities before considering the reply:

- List of faculty from the affiliating University.
- FDRs from the issuing Bank concerned.
- Fire Safety Certificate
- Building Safety Certificate
- Certificate of Land Use

The letter be issued to concerned authorities for verification and submission of their report within 15 days and thereafter, the matter be put up again before ERC for appropriate decision.

4. **AND WHEREAS**, letter were issued to the concerned authorities on dated 08.02.2023. The reply of the concerned authorities was received in ERC on 22.02.2023, 24.02.2023 & 01.03.2023.

5. AND WHEREAS, the matter was considered by ERC in its 326th meeting held on 23rd May, 2023 and the committee decided as under:-

The ERC in its 319th (Virtual) Meeting of the ERC held on 25th January, 2023 decided to verify the following documents from the issuing authorities:-

- List of faulty from the affiliating University.
- FDRs from the issuing Bank concerned.
- Fire Safety Certificate
- Building Safety Certificate
- Certificate of Land Use

The committee noted that letters to the authorities concerned were sent by the office of ERC on 08.02.2023 for verification.

The committee further noted that the verification of the following documents has not received so far from the issuing authorities:-

- List of faculty from the affiliating University.
- Fire Safety Certificate

In view of the above, the committee decided to issue reminder letter/s to the authorities concerned for verification.

The committee also noted that the concerned issuing authority of Land Use Certificate and Building Safety Certificate have informed that the documents have not been issued from their office.

In view of above, the Committee also decided that Final Show Cause Notice be issued under section 17 of the NCTE Act, 1993 to the institution before withdrawal of recognition to submit reply within 15 days from the date of issue of show cause notice."

6. **AND WHEREAS**, final Show Cause Notice was issued to the institution on 31.05.2023.

7. **AND WHEREAS**, A letter No. Ref. No. BSAEU/RO/480/2023 dated 26/07/2023 was received from Registrar, Baha Saheb Ambedkar Education University requested not to accept faculty list which is not authenticated by BSAEU.

8. AND WHEREAS, the matter was considered by ERC in its 331stmeeting held on 26th July, 2023 and the committee decided as under:-

"The original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, was considered by ERC and the Committee observed that:

• The Additional District Magistrate and District Land and Land Reforms Officer, Bankura, Government of West Bengal vide Memo No. 2086/LR/BNK/CONV/23 dated

10.04.2023 has informed that the Change of Land Use bearing Memo No. 89/Conv-04/LR/2015 dated 28.04.2015 is not issued by the office of District Land and Land Reforms Officer, Bankura, Government of West Bengal. The said Change of Land Use was submitted by the institution vide letter dated 31.08.2022 (received in ERC on 07.09.2022) in response to the Show Cause Notice dated 12.08.2022.

• The District Engineer, BankuraZilaParishad, Bankura vide Memo No. 911/ZP/2023 dated 24.02.2023 has informed that the Building Safety Certificate bearing Memo No. 1256/BZP/2021 dated 31.03.2021 is not issued by the office of Bankura Zila Parishad, Bankura. The said Building Safety Certificate was submitted by the institution vide letter dated 31.08.2022 (received in ERC on 07.09.2022) in response to the Show Cause Notice dated 12.08.2022.

Hence, Committee decided that the recognition granted to the institution for running B.Ed. Programme be withdrawn under Section 17 (1) of the NCTE Act, 1993 with effect from the end of academic session next following the date of communication of withdrawal order."

8. NOW THEREFORE, in terms of above decision of ERC, the recognition granted to Bishnupur Mallabhum B.Ed. College, Plot No.- 330, Vill - Mayrapukur, P.O.-Gossainpur, Tehsil/Taluka – Bishnupur, Town/ City - Bishnupur, Dist - Bankura, West Bengal - 722122, for running B.Ed. programme is hereby withdrawn with effect from the end of academic session next following the date communication of withdrawal order.

9. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

If an institution offers any course or training in teacher education after the coming into force of the order withdrawing recognition under sub-section (1), or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any school, college or other educational body aided by the Central Government or any State Government.

10. Further, if the institution is not satisfied by the order, they can prefer an appeal under Section 18 of the NCTE Act, 1993 in the "Online mode" available on NCTE's website www.ncte.gov.in within 60 days from the date of the issue of the order.
