#### WITHDRAWAL ORDER

WHEREAS, in terms of Section 14/15 of the NCTE Act, 1993, the recognition was granted to Magadh Teachers Training B.Ed. College, Vill- Danibigha, Street/Road- OLD G.T. Road, Po-Aurangabad, Taluka/Mandal-Aurangabad, Town/City-Dani Bigha, Dist- Aurangabad, Bihar – 824101 for conducting B.Ed. programme of one year duration with an annual intake of 100 students for (Two Basic Units) *vide* Order No. File No. BR-S/E-2/2008/2101 dated 20.11.2009 from the academic session 2009-2010, followed by revised recognition order for B.Ed. programme of two years duration with an annual intake of 100 students for (Two Basic Units) from the academic session 2015-2016 *vide* Order No. F.ERC/NCTE/APE00899/B.Ed.(Revised Order)/2015/32512 dated 30.05.2015 for an intake of 100 (Two Basic Units) from the academic session 2015-2016 and another vide Order No. F.No.ERC/252.6.10/B.Ed. (Addl.Intake)/2018/56330 dated 03.03.2018 for addl. Intake of 100 (Existing 100 + Addl. 100 =200) thus making the total intake of 200 (Four Basic Units of 50 students each) from the academic session 2018-2019 as per NCTE Regulations, 2014

- 2. AND WHEREAS, a letter No. NCTE-CDN016(13)/18/2018-CDN-HQ dated 02.08.2018 was received from NCTE HQ. In compliance of the said letter, the matter was placed before 284<sup>th</sup> meeting of ERC-NCTE held on 17-18 September, 2020 and the Committee decided to issue the Show Cause Notice to the institutions which have been recognized without NET qualified teachers. Accordingly, SCN was issued to the institution on dated 28.09.2020. The reply of the institution was received in ERC on 17.11.2020.
- 3. AND WHEREAS, the matter was placed before ERC in its 303<sup>rd</sup> (Virtual) meeting held on 24<sup>th</sup> March, 2022 and the committee decided to issue final Show Cause Notice under Section 17(1) of the NCTE Act, 1993 be issued to all ninety seven (97 TEIs). Accordingly, Final Show Cause Notice was issued to the institution on dated 09.04.2022. The reply of the institution was received in ERC on 20.05.2022.
- **4. AND WHEREAS,** the original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, was considered by ERC in its 331<sup>st</sup> (virtual) meeting held on 26<sup>th</sup> July, 2023 and the Committee observed that:

• In reference to the Final Show Cause Notice dated 09.04.2022, the institution has not submitted the faculty list after the date of issue of Final Show Cause Notice dated 09.04.2022.

- The faculty list submitted by the institution is only for session 2019-20 which does not have the date of approval by the Registrar of the University concerned.
- The institution has not uploaded faculty list on its website and the additional information as per Clause 7(14), 8(6) 10 (3) of the NCTE Regulation 2014 and Clause 2 (C) of the NCTE Regulations dated 28.04.2017.

Hence, Committee decided that the recognition granted to the institution for running B.Ed. Programme be withdrawn under Section 17 (1) of the NCTE Act, 1993 with effect from the end of academic session next following the date of communication of withdrawal order.

- **5. NOW THEREFORE,** in terms of above decision of ERC, the recognition granted to Magadh Teachers Training B.Ed. College, Vill- Danibigha, Street/Road- OLD G.T. Road, Po- Aurangabad, Taluka/Mandal-Aurangabad, Town/City-Dani Bigha, Dist- Aurangabad, Bihar 824101 for running B.Ed. Addl. Intake programme is hereby withdrawn with effect from the end of academic session next following the date communication of withdrawal order.
- 6. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

If an institution offers any course or training in teacher education after the coming into force of the order withdrawing recognition under sub-section (1), or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any school, college or other educational body aided by the Central Government or any State Government.

7. Further, if the institution is not satisfied by the order, they can prefer an appeal under Section 18 of the NCTE Act, 1993 in the "Online mode" available on NCTE's website www.ncte.gov.in within 60 days from the date of the issue of the order.
