- 2. AND WHEREAS, further, in terms of Section 14/15 of the NCTE Act, 1993, recognition was granted to Sahadev Chandravansi B.Ed. College, Vill.-Nawadih Kala, P.O.-Bishrampur, Dist.-Palamu, Jharkhand-822124 was granted recognition for B.Ed. programme of one year duration *vide* ERC/7-90.6(i).13/2008/13704 dated 06.11.2008 with an intake of 100 students (Two Basic Units) from the academic session 2009-2010, followed by revised recognition order for B.Ed. programme of two years duration *vide* Order No. F.ERC/NCTE/APE00910/B.Ed.(Revised Order)/2015/32684 dated 31.05.2015 with an annual intake of 100 students for (Two Basic Units) from the academic session 2015-2016, as per NCTE Regulations, 2014.
- **3. AND WHEREAS**, the institution has submitted the Representation dated 27.03.2023 received on 03.04.2023 requesting ERC to accord permission to change the affiliating university as well examining authority from the earlier university, namely the "Nilamber Pitamber University, Daltonganj, Palamu to "The Ramchandra Chandravansi University, Bishrampur, Palamu" since inception of RCU".
- **4. AND WHEREAS**, the matter was considered by the ERC in its 331st (Virtual) meeting of the ERC held on 26.07.2023 and the committee decided as under:-

College for B.Ed. course. Orders be issued accordingly.
