ORDER

WHEREAS, Loyola College of Education, Namchi, South Sikkim, Sikkim - 737126 (SI-S/E-1/96 & APE00456) was granted recognition for conducting B.Ed. course with an intake of 50 vide orders dated 12.02.1997, 06.03.1998, 02.03.1999, 14.01.2000 and 05.02.2001 respectively. Permission was granted for additional intake of 50, thus total intake of 100 from the academic session 2006-2007 vide order dated 14.02.2006, followed by revised order vide No.31795 dated 20.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

- AND WHEREAS, the ERC in its 254th Meeting held on 16th 17th April, 2018 considered the matter and as decided, Show Cause Notice u/s 17(1) was issued on 20.04.2018 to the institution.
- AND WHEREAS, the ERC in its 272nd Meeting held on 30th 31st May & 1st June, 2019 considered the matter along with the reply dated 07.05.2018 submitted by the institution in response to SCN and Final Show Cause Notice u/s 17(1) was issued on 19.06.2019 to the institution on the following grounds:-
 - (i) The submitted faculty comprises of 1+10 instead of 1+15 required under NCTE Regulations, 2014.

(ii) Building plan not submitted.

- (iii) The validity of photocopy FDR of Rs.5,98,570/- in single mode has been expired on 04.02.2019. Another photocopy FDR of Rs.9,75,768/- is in single mode. FDRs of Rs.12 lakh (Rs.5 lakh+Rs.7 lakh) in joint mode with RD, ERC, NCTE along with bank certificate required to be submitted.
- AND WHEREAS, the ERC in its 275th Meeting held on 27th July, 2019 considered the matter along with the reply dated 27.06.2019 submitted by the institution in response to Final Show Cause Notice and observed as under:
 - a. Faculty comprises 1+6 (full time) against the requirement of 1+15 as per NCTE Regulations, 2014 for running 100 intake of B.Ed. course. Part-time faculties are not accepted.

b. The institution does not fulfill criteria (01 Principal + 07 faculties) as per NCTE Regulations, 2014 even for running one basic unit i.e. 50 intake.

- 5. NOW THEREFORE, recognition granted to the institution viz Loyola College of Education, Namchi, South Sikkim, Sikkim 737126 (SI-S/E-1/96 & APE00456) for B.Ed. course is hereby withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.
- 6. Further, if the institution is not satisfied with the order, they can prefer an appeal under Section 18 of the NCTE Act in the "Online mode" available at NCTE's website www.ncte-india.org within 60 days from the date of issue of the order.
