ORDER

WHEREAS, Loyola College of Education, Namchi, South Sikkim, Sikkim-737126 (Code No. SI-S/E-1/96 & APE00456) was granted recognition for B.Ed. course with an intake of 50 from the academic session 1997-1998 vide ERC Order No. 2802(11) dated 12.02.1997. Permission was granted for additional intake of 50, thus total intake 100 from the academic session 2006-2007 vide order dated 14.02.2006, followed by revised order vide No. 31795 dated 20.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

2. **AND WHEREAS**, the ERC in its 275th (Part-2) meeting held on 27th July, 2019 considered the matter in its meetings held time to time observed as under:

 1^{st} show cause notice u/s 17(1) issued on 20.04.2018, followed by final show cause notice dated 19.06.2019 and the institution is still deficient on the following grounds:-

- (i) Faculty comprises 1+6 (full time) against the requirement of 1+15 as per NCTE Regulations, 2014 for running 100 intake of B.Ed. course. Part time faculties are not accepted.
- (ii) The institution does not fulfill criteria (01 Principal + 07 faculties) as per NCTE Regulations, 2014 even for running one basic unit i.e. 50 intake.

Recognition granted to B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.

Accordingly, withdrawal order u/s 17(1) was issued vide order No. 61364 dated 22.08.2019 to the institution and all concerned.

- 3. **AND WHEREAS**, the institution preferred an appeal to the NCTE Hqrs. against the ERC's order dated 22.08.2019. The Appellate Authority vide its Order No.89-377/E-136549/2019 Appeal/34th Mtg.-2019/22nd November, 2019 dated 05.12.2019 remanded back the case to ERC for revisiting the matter after the appellant has submitted to it the recent list of faculty appointed with the approval of affiliating body.
- 4. AND WHEREAS, the ERC in its 279th meeting held on 14th 16th February, 2020 considered the original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and appeal order dated 05.12.2019, and decided as under:-

Restoration of recognition order of B.Ed. course to be issued.
