**WITHDRAWAL ORDER**

**WHEREAS**, in terms of Section 14/15 of the NCTE Act, 1993, District Institute of Education and Training (DIET), Pasighat, East Siang District, Arunachal Pradesh-791102 was granted recognition for conducting D.El.Ed. programme of two years duration with an annual intake of 50 students *vide* order No. ERC/7-73.6(a).23/2007/62354 dated 02.02.2007.

2. **AND WHEREAS**, the Show cause notice under section 17 (1) of NCTE Act, 1993 was issued on 04.08.2022 as per decision of 306<sup>th</sup> meeting of ERC held on 12<sup>th</sup> to 13<sup>th</sup> July, 2022 to the all institutions which have not filed PAR on the ground that the institution has breached the condition of recognition as per the provision of Clause 8(12) of NCTE Regulations, 2014 and also clause 7(14)(i) of NCTE, Regulations, 2014 which is related to uploading information on the website.

3. **AND WHEREAS**, the institution has not submitted reply of show cause notice dated 04.08.2022. The matter was again placed before 311<sup>th</sup> meeting of ERC held on 11<sup>th</sup> Oct, 2022. The Committee decided that Final Show Cause Notice be issued before withdrawal of recognition under Section 17 of the NCTE Act, 1993 to submit reply within 15 days from the date of issue of Final Show Cause Notice. As per decision of ERC-NCTE, Final SCN was issued to the applicant institution on 28.10.2022.

4. **AND WHEREAS**, the original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, the matter was considered in 316<sup>th</sup>(virtual) meeting held on 20<sup>th</sup> December, 2022 by ERC and the Committee observed that the institution has not submitted the reply of First Show Cause Notice dated 04.08.2022 and Final Show Cause Notice dated 28.10.2022 issued to it for non-submission of Performance Appraisal Report (PAR) for the academic session 2020-21. Hence, Committee decided that the recognition for D.El.Ed. Programme be withdrawn under Section 17 (1) of the NCTE Act, 1993 with effect from the end of academic session next following the date of communication of withdrawal order.

5. **NOW THEREFORE**, in terms of above decision of ERC, the recognition granted to the institution viz. District Institute of Education and Training (DIET), Pasighat, East Siang District, Arunachal Pradesh-791102 *vide* order No. ERC/7-73.6(a).23/2007/62354 dated 02.02.2007 for running D.El.Ed. programme is hereby withdrawn with effect from the end of academic session next following the date of communication of withdrawal order.

6. **FURTHER**, if the institution is not satisfied by the order, they can prefer an appeal Under Section 18 of the NCTE Act, in the "online mode" available on NCTE's website [www.ncte-india.org](http://www.ncte-india.org) within 60 days from the date of the issue of the order.
